Potluck dinner featuring wild game begins at 6 p.m. (bring a dish to share, and your own plate and utensils). The Gallatin Forest presentation will follow at 7 p.m. followed by a short general meeting at 8 p.m.

Topics of discussion may include but are not limited to:

Brian McNeil will discuss the necessary information and paperwork for us to work on the Forest Service trails as a volunteer organization.

They can discuss the upcoming season and any projects that they would like us to work on. We have money set aside for trail projects and need some direction from the Forest Service.

They will discuss the recent changes that will take place when Mary Erickson accepts her new duties in managing the Custer National Forest.

A copy of the schedule we put together at the January meeting will also be included in this newsletter.

Our February meeting will be a wild game feed and potluck starting at 6:00PM and will be followed by a presentation by former member Jose Castro and trail supervisor Brian McNeil of the Gallatin National Forest Bozeman District office. There are a number of new things going on in the Forest Service and it should prove to be an interesting discussion. Mary Erickson was unable to attend this year as she had a prior commitment in Missoula but she sent me an email saying she enjoyed our meeting last year shortly after arriving at her new job. Members Needed for Gallatin County Resource Advisory Committee

Bozeman, MT... The Gallatin National Forest and Gallatin County are seeking candidates for a Gallatin County Resource Advisory Committee (RAC). Membership is open to Montana residents.

Because this is a newly established RAC under the Secure Rural School (SRS) and Community Self Determination Act of 2000, 15 RAC members and alternates are needed. The purposes of the Secure Rural Schools Act include making investments and creating employment opportunities by prioritizing and implementing projects that improve the maintenance of existing infrastructure, implement forest stewardship objectives, and restore and improve land health and water quality.

Members of a RAC will review projects proposed under SRS Title II by participating counties, propose projects and funding, and coordinate with the Forest Service in recommending Title II projects. RAC members also provide opportunities for other interested parties to participate in developing Title II projects, monitor project implementation, and make recommendations for project adjustments or changes as needed.

Under the law, the 15 volunteer committee members are divided into three categories, and each member represents a particular set of interests. These categories could include representation from organized labor, developed recreation, off highway vehicle users, commercial recreation, energy or mineral development, commercial timber industry or non-timber forest product harvester groups, grazing permittees or holders of other land use permits, and commercial or recreational fishing interests. National environmental organizations, regional or local environmental organizations, wild horse and burro interests, wildlife or hunting organizations, watershed associations, archaeological or historical interests, and dispersed recreation representatives are also needed. Finally, representatives from state elected officers or their designees, county or local elected officers, American Indian tribes near the RAC area, school officials or teachers, and the affected public at large are needed. Committee members serve four-year terms.

The Secure Rural Schools law gives states and counties payments for the next four years, tied to the amount of national forest land in the county and other factors. Counties designate a portion of the funds to projects reviewed by the RAC.

Any Montana resident interested in serving on the Gallatin County committee must complete an application form that will be used for a required background check. Applications are available online at http://www.fs.fed.us/r1/gallatin/. Applications and further information is also available at Gallatin National Forest offices or the Gallatin County Commissioner's office or by calling (406) 587-6701 or (406) 582-3000. A motion to approve the minutes of the past board meeting as posted in the newsletter were moved and seconded.

Membership: Membership is coming along slowly as it always does this time of year. Please encourage fellow members to renew.

Issues: The Gallatin Forest Travel Plan lawsuits were combined into one and a preliminary judgment has been made and sent to Judge Malloy. The preliminary findings ruled in favor of maintaining the wilderness study areas as wilderness which would impact some of the current travel plan. Judge Malloy has yet to pass judgment on the issue so things are still pretty much up in the air.

The Gallatin Forest and Custer National Forest have been consolidated to save funds. Mary Erickson will take over as the Custer Forest Supervisor as well as the Gallatin Forest Supervisor. Brian McNeil will take over as the Hebgen district trails supervisor in addition to the Bozeman district.
