Bills

Publicity

Trail Crews

Rich is trying to set up a half-day meeting this month with folks from the Forest Service and two or three BCH board members. Very important to tell them we need their input on where they need us. Also, he will recommend trail classification of Class 3 on all trails that have been designated "horse and pack animal trails". Class 2 is just not sufficient.

Issues, 2nd round

Dan Marsh had joined the meeting at this point. Two issues to watch:

Tester's Forest Bill. Tester will make another attempt in the New Year.

New World Gulch timber sale and logging: Before the club puts in any time repairing or rerouting the trail, we should wait and see what kind of logging roads get put in. It could save us a lot of time.

Busines

Although planning for 2011 will be handled at the general meeting, there are a few projects that need immediate attention.

Janice has requested that we schedule the Safety Clinic in early May. The Circle L has become very popular and we need to reserve a date for our event. It was decided that we will try for May 7th, 2011.

Copper City scheduling was brought up as well. It was decided to tentatively shoot for May 14th, 2011. This will be weather dependent.

Dates for the projects submitted and approved for the RAC Grant need to be decided. Those projects are:

Repair work at Window Rock (in the Hyalite area)

Replace corrals at Windy Pass and build new corrals at Porcupine creek

Clark Kinney made a motion to rent the cabin at Window Rock and the cabin at Windy Pass for one night each now, while there is a chance to get the dates we need. Stacy Bragg seconded the motion. Motion was passed.

Rich Inman will reserve the cabins, Window Rock for July 16th and Windy Pass for August 20th, if those dates are still available.

Dick Haines sent an email to several board members, suggesting metal corrals. The board discussed this option and reviewed the photos and plans he sent via email. There may be situations in the future where this type of corral will be more suitable than the wood post corrals we are currently building.

The remainder of the board meeting was a closed meeting, with only board members present.
