

PRESIDENT'S REPORT:

Hello Horseman,

Summer is in full swing and the heat as well as fire season is here. Everyone be careful during fire season both with fire and stay out of the way and don't get trapped in the back country by a forest fire.

Thanks to Lew and Dan Porter for leading the trail crews, they are doing a great job of coordinating the trail crews. Lots of work has been done. If you have not been out on a crew yet give Dan or Lew a call. Dan leads the Sat crew and Lew the Wed crew.

We are planning the August A-B Wilderness trip to build a new fence at Slough Creek. Dates are August 23-29 and you may come all of the days or only part of them. Let me know as we plan for food and equipment to be taken in. The ride in is on a old two track most of the 14 miles. There is one hill right at the beginning from the trailhead other than that it is mostly flat with water available for the horses along the way. It will be dry and dusty unless we get rain the day you travel. You do not need a pack horse to participate, we will have pack horses for your gear. If you are coming to help without a pack horse, please limit your load to a sleeping bag and your personal items to 30 lbs. If it goes over 35 lbs we will remove 5 lbs of items. We will provide food; if you need a specific diet please contact Molly and she will coordinate with you. There will be tents provided in a grassy area around the cabin with a fence all around. Couples can share a tent. Most of you know my cooking by now and it will be typical western camp food. BBQ pulled pork, Brisket, Chicken and hamburgers with sides every evening and breakfast will be typical eggs, bacon, biscuits, pancakes and etc. Lunch will be sandwiches.

Please don't bring rank horses that kick and fight other horses. Assume there will not be cell service. I hear that sometimes it is possible to text but it is unreliable. You must have a current (within the last 12 months) Coggins test on your horse before you can go into the YNP.

Any questions, please call me so we can plan accordingly. RSVP is mandatory by the August 20th meeting. All are welcome this will be a great trip and fishing will be outstanding in Slough Creek so bring your fly rods. We will take a side trip to French's grave one day. Let's make this a great adventure and project. —*Henry*

TRAIL CREW

July 10: Ten BCH'ers met at the Porcupine trailhead on Friday morning, July 10, to tackle several trails in the area. One group consisting of Vern, Bruce, Tom, Lawrence and Kathy, were tasked with heading up Trail 34 toward Ramshorn Lake. Just as we were leaving the parking lot one of Vern's horses blew up into a bucking fit worthy of a rodeo arena and resulting in a later departure than originally planned. We finally hit the trail at 10:00 am, and after 1-1/2 hours of riding we encountered our first deadfalls. From that point the trail was regularly blocked by downed timber, to the tune of 38 large logs for the chainsaw and 8 smaller trees for the silky saw. At 4:30 we had not yet made it to the lake but decided it was time to head back to the trailhead, where we finally arrived at 7:00 pm. It was a long trip, 17 miles, and lots of work, but a very

WEDNESDAY TRAIL CREW

July 15, at 0900, Rich, Connie, Tim, Wayne, Kenji, and Mark left the Buffalo Horn trail head. It was a chilly 32 degrees and quite cool for the first two hours. Even saw frost on the grass. We rode trail #1 to the trail #39 junction then on past the Buffalo cabin to Tepee Pass. Did not have to clear any trees as the Forest Service already had been there earlier. From Tepee Pass to Dailey Pass we had to cut 12+ trees most of which were big and narly with multiple large limbs. These were old dead snags that were just waiting for the right wind to topple them. We stopped for lunch on a high vista point about half way between Tepee and Dailey Pass. What a view! At Dailey Pass we met Dan's trail crew who had just completed clearing trail #57 to the pass. This was a surprise to us but welcomed as we then got to ride back to the trail head without getting off our horses to cut any trees. All we had to do was fight the horseflies which were quite intense much of the time. Twas another beautiful day enjoying the splendor of God's back country.

The other group consisting of Dan, Vern and Mary, Corrine and Jim and Laurie were headed to Ramshorn but due to a navigation error by Dan instead of taking the #151 trail to the #161 to Ramshorn Lake as planned ended up going up the pack trail to Daily Pass. We ended up helping the other crew by cutting out over 35 trees including a few leaners that we had been passing up over the years that needed removal. We wound up only going 12 miles but it was a lot of work and the horse flies got real bad in the afternoon. Vern had some trouble with his mare that decided she wanted to buck back to the trail head. Vern walked her out for a mile or so and she seemed to settle down enough for him to ride the rest of the way back. 
















PACKING CREW
