

MINUTES OF JANUARY 2020 MEETING

Dan Porter moved to approve the minutes as written; Corinne seconded; the motion passed.

TREASURER'S REPORT

Corey and Cody, Forest Service, Bozeman Ranger District, presented their annual report on upcoming projects. Corey said the main priority is the forest plan revision; Bozeman district projects will include a couple of large forest health projects (North Bridger and the Bozeman Municipal Watershed Fuels Reduction project), aspen restoration in Porcupine area (may cause prescribed fire work and related closures), road work on Hyalite Road from the dam to the Grotto split, the Spanish Creek fish project, and the Upper Deer Creek project. Cody said everyone needs to sign the volunteer form; there will be a 6-person trail crew this summer; there will be CPR/1st aid training sessions starting in April and saw training (probably be in May); projects will include upper high lakes trails in the Spanish Peaks (they might need pack support for this), the upper Beehive trail, the upper Swan, and the Hyalite Lake trail.
