

2020 GALLATIN VALLEY BCH VOLUNTEER HOURS

We had a great year in 2020 despite fighting the added trouble of the COVID-19 pandemic. We also had to deal with our trail boss extraordinaire Larry Thomas taking a step back from his trail boss duties. Thanks to Dan Porter and Lew Goodpasture for stepping up to the plate and filling Larry's boots! Dan Porter led the Saturday Crew and also started early in January with a couple of trips to clear brush at South Cottonwood. Dan also took on the task of retreading the High Lakes trail which has not got much attention in the last few years and was becoming dangerous to ride on. Lew took over the Wednesday crew and did a great job managing two crews to keep the size of the crew down during the pandemic. We had to get special approval from the Forest Service and submit a plan of how to deal with any COVID-19 cases that may have come up while doing the volunteer work. We also had a new requirement to be able to carry a firearm to dispatch any stock that required a back ground check and a letter of authorization from Mary Erickson. We had over 40 different projects this year with over 2,162 hours and 529 trail miles and a whopping 14,137 travel miles and 313 stock days. When the going rates for volunteer time and stock are totaled we donated over \$113,182 to the volunteer effort for the year. Aside from Dan Porter, Lew Goodpasture and Henry Glenn for their countless hours organizing and

riding heard on all of the volunteer folks there are some notable volunteers that went above and beyond this year. Kenji Aoki was on just about every project including the early ones and amassed 2,186 miles himself in hauling stock to the trailhead. The next highest mileage total went to Lew with 1,434 followed by Dan Marsh with 1,244 and then Henry Glenn with 1,104. We are waiting to find out if there will be any leftover RTP money around mid-November and if so we will submit to that grant because it has to be used this year. Our RAC grants are good for another year so the remainder of our mileage will be applied to those grants. We get more with the RTP grant per project because it pays more in mileage and also pays for trailer and stock use while the RAC grants only cover mileage and use a formula based on the distance from the district office instead of actual mileage. We had over 26 members that participated in the volunteer effort this year so give yourself a pat on the back for a job well done! You should feel a sense of pride in that we consistently produce more hours than chapters that are more than double our size. We also consistently have more projects per year then the other chapters.
