


#### **FUN RIDE**

July 3: BCH members and one guest braved the heat to make a "short" ride over to the North Fork of Spanish Creek where we ate a quick lunch and cleared two dead snags that had fallen across the trail right at the F.S. boundary. From there, Lew and Kenji rode on towards Willow Swamp a short distance while Tom and I rode on up the North Fork. Returning we noted that one sign post had rotted off and needs replacement and another is split and broken off. (see photos) As part of our ongoing sign replacement project, hopefully a new sign is being made by the Forest service to replace the one on Divide Peak at the head of Storm Castle and a new one can be made for the Big Brother junction. The need for more trimming and water bar maintenance was noted in the trail section beginning approximately 3 miles in and all the way to the North Fork. A new sign post potentially can be cut on site to reinstall the North Fork sign during the next work day in that area.



On Monday July 12, the Gallatin Valley Back Country Horsemen with Rich, Lew and Dan packed in a Forest Service Crew up Elkhorn trail about 3.5 miles to their camp. Another Forest Service Crew had gone in ahead and cleared the trail so we didn't have to cut our way in. We packed in their food and tools and will go back in to pick them up on Thursday.













#### WEDNESDAY TRAIL CLEARING

July 21: Lew sent a crew of 5 including Larry, Rich, Dan, Tim and Jack to clear First Creek trail. What stared out as a cool, clear, beautiful morning soon turned into the beginning of chainsaw day as we crossed the first creek and headed up the mountain. At the next creek crossing, we encountered a large spruce (18"+) laying across the trail. After nearly an hour of cutting limbs and sawing out the main tree we were ready to head on up the trail. It took us nearly 6 hours to clear the trail to the First Creek/Hidden Lakes divide. We cleared 35 trees to get to the divide. Most of them were 18 inches and larger. Somewhat challenging when you only have an 18 inch bar on your saw. Coming back down the trail we had the pleasure of a thunder storm that got us quite wet before we put on our slickers and rode the rest of the way to the trail head. My thanks to a great crew who spent the day pushing and lifting big logs. I am sure they were as tired as me when we arrived back at the trail head. Thank you Pepsi for the cold drinks. It was a fine day in God's back country.

The other crew of 4 consisting of Lew, Kenji, Wayne and Connie headed down the Porcupine trail to Onion Basin. They went about 16.5 miles and sawed out more than 65 logs.

### SATURDAY TRAIL CLEARING

July 24: Five GVBCH chapter members, Lew, Marianne, Curt, Rachel, and myself rode in to the North Fork on the Cherry Creek Trail #401, arriving at the North Fork at 11:15 am.

After a quick lunch Lew and Curt back tracked a short distance to cut a new 8 ' sign post from deadfall while Marianne, Rachel and I began excavation for the new post at the Willow Swamp/North Fork Y.


It was discovered that the old post had only been supported by a few boulders stacked around it. The new post installed is much more substantial and buried 2 feet in the rocky soil.

It should last a long time and guide those passing thru.

Returning we stopped to do some light trimming and water diversion along the way. The need for installation of steps was noted in several locations.

The Spanish Creek "Trailer Only " parking was completely filled with trailers by 9am that day when we got a leg up and was still full when we returned, however we saw no other trail users that day on the 401.

We did encounter one lone bull buffalo along the trail . Fortunately he was inside the Turner's Ranch fence . He caused only momentary alarm for our equestrian mounts as we passed by and he was equally satisfied with moving away in to the timber below. —DP



#### WEDNESDAY TRAIL CLEARING

July 28: The Wednesday crew met at the Cinnamon-Buck #6 trail head at 9:00AM. The weather was pleasant and not too smoky. After doctoring up my horse who managed to scrape up his rear feet in the trailer, we headed out at about 9:20AM. The crew consisted of Dan, Larry, Jim, Tim, Kenji, Wayne and Connie. Wayne had his white Arab instead of his usual Canadians. We didn't run into any logs until we started up the trail to the outfitter cabin and didn't make it 50 yards before our first tree. We only had to cut out 25 trees but they were mostly larger than 18 inches and blocking the trail with no safe way around them. Once we got past the outfitter cabin there was a creek crossing that had deep holes that were covered by tall grass. Wayne's horse stepped in one and went in up to his belly and tipped over on top of Wayne. Luckily neither the horse or Wayne was hurt but it is a spot that desperately needs a bridge. The rest of the way around was cleared by another crew that did a great job of making a wide path. Kudos to whoever did the clearing. We took the Meadow Creek Cutoff trail then on the Cinnamon Meadow #30 trail where we finished the 12 mile loop and got back to the trail head around 4PM. We enjoyed a cold beverage and headed for home.










#### SATURDAY TRAIL CLEARING


