The Spanish Creek fish reintroduction project continues this year.

The five year temporary target shooting closure for the Hyalite expires this year. The Forest Service has requested a one year extension with hopes of making it permanent. Another site is being sought that would be further away from the high density use of the Hyalite area.

Weed spraying will be happening in the Bridgers and Bangtails.

The Bridger Foothills Fire rehab is a priority. All the salvage logging going on in there is on private property.

OLD BUSINESS:

Poker Ride: Kathy reported on the progress of plans. The ride will be July 10. Registration will be on-line only. Water will be available at the pop stops. Sack lunches will be provided. Volunteers for set up, day of and take down will be sought when we get closer in time.

AB Wilderness: Henry announced that the Slough Creek cabin fence mending project will be August 8-14. It's lots of work but lots of fun so let Henry know if you'd like to join the crew. We' have pack stock to haul belongings.

Next month's program will be provided by the Fish and Wildlife Biologist.
