#### **SEPTEMBER 3: FUN RIDE TO HYALITE LAKE**

Kenji and I trailered up to the Trail # 427 trailhead on the last weekend of the "Time Share" for that trail. Getting an early start ahead of the forecast high temps, we were in the saddle and on the trail to the left up the ridge rather than the wheel chair accessible route by 8:40 am. This portion of the trail is in fair condition and well traveled but we had it to ourselves this morning. 

### **SEPTEMBER 17: CLIFF CREEK TRAIL**

Six GVBCH members went "over the hill" and up the Paradise Valley headed for Big Creek for a day of riding and trail maintenance. Leaving the trailhead at Big Creek Station at 10:30 am with Marianne on "Rachel" in the lead we took the fork up Cliff Creek and rode until 3:00 pm stopping only to clear the frequent virgin timber deadfall. Most were over 10" diameter and many 15" or more. At 3pm, with two dead batteries on the Stihl and a unanimous decision it was time to go home, we turned back, reaching the trailhead at 4:15 with Rachel setting the pace again for an estimated 5 miles each way. During the ride we saw blue sky and sunshine, a short hail storm, and as we rode out a lot of high elevation thunder and light showers. Thank you Kenji, Larry, Carmen, Lew, and Marianne for a great ride thru an incredibly beautiful canyon and for helping "Wild Montana" to reopen the Cliff Creek trail.—DP













#### SEPTEMBER 21: LITTLE HELLROARING TRAIL TO INDIAIN RIDGE TRAIL

Three members, Lew, Laurie and Bruce met at Spanish Crk trailhead with the plan to get there earlier than usual and do a long ride up the North Fork trail and then back on the Camp Crk trail, a 21 mile loop. Unfortunately, Laurie got caught up in a line of southbound traffic that was held up due to an 18 wheeler crashing and blocking the northbound lane of Hwy 191. She creeped South slowly and it took her 1 hour and 45 minutes to go from Gateway Exxon to the turn toward Spanish Crk TH. An 8:30 departure turned into a 10:15 departure so we decided on a shorter ride onto Little Hellroaring Trail. We left the trailhead in a very thick fog, allowing about 200 ft visibility. We cut 10 small trees from the trail as we rode up. After about an hour of riding, we climbed above the fog which resulted in a spectacular sight, looking down on this blanket of fog. We had lunch near the junction of Indian Ridge trail in a small clearing, mostly sunny. We turned back at the junction and walked about a mile to mile and a half and used loppers and Silky saw, cutting small trees and brush away from the trail. We travelled a total of 10 trail miles and were on the trail for about 6 hours. Thanks to Laurie and Bruce for helping out this week.—Lew












### SEPTEMBER 25: 407 TRAIL

Larry, Carmen, Larry Bill, and I rode up the 407 trail on a beautiful fall day. Massive recent tread repair by the Forest Service there has made this trail much safer for equestrian use. Thank you, Josh for getting this project completed. We then dropped in to the Falls creek drainage, riding past Upper Falls Creek Lake which lies in an idylic basin meadow at timberline along the trail.
