BOARD MEETING MINUTES MARCH 15

Roll Call: Henry Glenn, Sid Boswell, Jim Wing (proxy for Carmen Matzick), Kathy VanDyke, Devon Kerley, Bob Criswell, Dan Porter, Nanci Marx, Laurie Connelly, John Mutter

Called to order by Henry Glenn.

MINUTES OF FEBRUARY 2024 MEETING

Devon moved to approve the minutes as written; Laurie seconded; the motion passed.

TREASURER'S REPORT

Jim reported on the chapter's savings and checking accounts. Laurie moved to approve the report; Kathy seconded; the motion passed.

Sid reported on research done by several board members regarding investment options for a portion of the savings account. We can get a 3-month CD at 4.8% with an automatic rollover at First Security Bank; conversely a money market would pay less than 1% interest. Sid made a motion to invest \$10,000 in a 3-month CD at First Security; Kathy seconded; the motion passed.

A discussion was held regarding the chapter's savings, and it was agreed that some funds should be used for projects, possibly with other entities. Dan Porter will contact the Forest Service to determine their need for additional project funding. Other recipient suggestions would be appreciated.

OLD BUSINESS

1st Aid: Dan Ported noted that almost everyone needs to obtain a first aid recertification this year. Henry noted that Josh with the Forest Service said the class would likely be in May.

TRAIL PRIORIES

Dan Porter noted that the chapter will need to work at setting trail priorities this year given the increased requests for assistance (Hebgen, Madison, and other areas are short-handed). He also noted that we did not have a planning meeting this year and said we should have a meeting every year to discuss priorities for the upcoming season.

New Business

Board meeting time change: Dan Porter stated that he feels 30 minutes is insufficient for board meetings and proposed that they be 60 minutes (at least during the summer months). After discussion it was decided that the meetings would be from 6:00-7:00 pm, with the regular meetings starting at 7:00 as they do now.

Equipment: Henry got a cross-cut saw at the annual meeting and suggested that the chapter purchase it. Sid made a motion to purchase the saw for \$200 for chapter trail use; Laurie seconded; the motion passed.

John suggested that someone should inventory the chapter's trail equipment. He and Dan will take on this task.

Adjournment: Sid moved to adjourn the meeting; Nanci seconded; the motion passed.

Trail: This year will follow the north (counterclockwise) route. There have been several requests for a shorter option. Ester made a motion to have two routes this year; Devon seconded; the motion passed.

Advertising/promotion: We need to put out more posters. Henry suggested providing the poster to every state chapter with a FB page.

Prep days: Trail clearing will be on Wed., July 3; flagging and set-up/potluck will be on Fri., July 5; the ride will be on Sat., July 6.

The trailer should be inventoried in advance of the ride.

Fee: John Mutter made a motion that the registration fee be raised to \$35; Devon seconded; the motion passed.

Prizes: We will continue to have several large prizes and will also have door prizes as was done in the past. The winners of the big prizes need not be present to win, however the door prizes winner will need to be present. We're aiming for a reasonable number of door prizes, perhaps 50 or so.

Big prizes: The following members will contact these business for big prizes: Madison River (John Mutter); Rocky Mountain Hat and Four Corners Saddlery (Dan Porter); Kenetrek boots (Dan Marsh); Montana Canvas (Rich Inman); Murdoch's (Marianne).
