A group of volunteers met at Porcupine Creek Trailhead to pack in 20 - 6' x 12" x 3" wood planks. 

#### TRUMAN GULCH PACK IN AND OUT — JULY 16

#### **HELLROARING — JULY 20**

Six members met at the Hellroaring Trailhead for Trail #81 to make sure the trail would be clear for the Forest Service Packin coming up soon. We were in the saddle by 8:45 am sharp with our trail maintenance sign already deployed and parking already at a premium. Hikers and canines were plentiful.

We rode in to the North Fork JCT which the sign says is 5 miles, however, Dean Vine's GPS indicated just under 12 miles traveled at the end of the day. We encountered only minimal obstacles, removing 5 deadfall as well as clearing 3 waterbars of sediment on the return trip. We ate lunch at the North Fork JCT and cleared two large deadfall that were blocking the stream crossing there just after lunch. One required some barefoot "hydrologic engineering" by Mark to ease the cut logs downstream and below the crossing.

The trail is in fairly good condition with generally very gradual gradient along rather steep sidehills but shrubs and saplings are beginning to encroach on the upper side of the trail in many places and will soon need attention.

All in all it was a nice day and a great ride in the mountains with cooler temperatures that were not nearly as appreciated as we could have—until we returned to the valley and exited our AC vehicles at home to 91 degree temps.

Thank you Larry, Carmen, Marianne, Dean, and Mark with his packhorse for enjoying another great day in the mountains together, "living the dream", and helping to keep our trails open to equestrian use. — Dan Porter
