#### TRAINING DATES

Defensive Horsemanship training is required for any member wishing to ride their equine on a Forest Service trail project. (It is not required for club trail rides.) Once earned, the card is good for 3 years. Defensive Horsemanship clinics will again be held at the C-Max Stables in Corvallis, on Bass Lane, off Eastside Highway. The dates are as follows:

May 8 and 15: **Obstacle Courses**: Four sessions (9 AM-noon, or 1-4 PM) will be offered, with 8-10 people in each session. This is the riding part of earning a Defensive Horsemanship card and you will bring your own horse, mule, or donkey. While first timecard applicants will get first choice, there is generally room for current DH card holders to participate for a "spring tune-up."



**Trail Riding Etiquette** by Pat Barriage, Horse Riding Assn., Alberta Edited for Length

BRBCH will start projects this month and this seems like a timely article to remind us to remember "the rules of the road" when riding in groups...

Etiquette and safety are closely related, in many cases, a lack of one creates a breach of the other. Poor etiquette typically leads to unsafe

situations, while good etiquette paves the trail for a safe riding experience. It is the right and responsibility of every trail user to ensure their own safety and expect safe practices from other trail users. Exercise caution at all times, and follow guidelines and rules of the trails. Contribute to a safer outdoor experience for all trail users by always practicing the 3 Cs of Trail Etiquette - Courtesy, Communication and Common Sense.

 Trail etiquette rules indicate cyclists must yield to hikers and horses, and hikers must yield to horses. Though most hikers and bikers will yield the

- right-of-way to horses, remember that many folks do not have experience with horses and may not know what to do.
- As a rider, you have the responsibility to manage your animals on the trail. It is not recommended to bring "green" horses to multi-use trails.
- Make sure the trail matches your horse's current fitness level. Horses need to build their strength and endurance gradually, just like humans.
- Check your tack regularly for proper fit.
- Never go trail riding alone. Always let someone know where you plan to ride and approximately when you expect to return.
- Carry a cell phone, trail map, and compass on your body, not on your horse.

- Attach an identification tag to your horse's gear.
- Tie a red ribbon on your horse's tail if he has been known to kick.
- Carry a first aid kit for human and horse.
- Know how to monitor your horse's vital signs.
- Balance the load in your saddle bags as evenly as possible, to within a few ounces.
- Use insect repellent on both you and your horse.
- Alcohol and riding do not mix. Confine your alcohol consumption to your camp area.
- Dismount to smoke. Ensure the cigarette butt is completely extinguished and pack it out with you.
- Leave gates as you find them, open or closed.
- Wait for gate openers/closers.
- Do not disturb wildlife or stock at large.
- Always be vigilant for other users in front of you, behind you, and meeting you at trail intersections. With a friendly greeting, do your utmost to let your fellow trail users know you're coming.
   Strive to make each pass a safe and courteous one.
- Ride at the level and speed of the least experienced rider.
- Before increasing speed, get unanimous consent from the group.
- Make sure to walk and rest after periods of trotting.
- Leave one to two horse lengths between horses. Make sure you can always see the heels of the horse in front of you from between your horse's ears.

- Allow your horse the opportunity to drink at water crossings. Wait for others in your group to drink before leaving the watering area. Move downstream to allow ample room.\
- Wait for riders who might be having difficulty crossing water or bridges.
- Warn other riders if you will be passing them from behind, and overtake other riders on their left side. Pass oncoming riders, left shoulder to left shoulder.
- If your horse is getting too close to a tree or obstacle and it looks like he might hit it, slightly turn his head toward it and use your inside leg (leg closest to the obstacle) to yield him away from the obstacle.
- Lift low hanging branches up over your head, rather than pushing them forward, to ensure they don't snap back at the horse behind you.
- Socializing on the trail adds to the experience, but remember to always pay more attention to your horse and his body language than to the conversation.
- Always return to the trailhead at a walk.
- Make sure to cool your horse down properly to relieve and prevent lactic acid buildup in his muscles.
- Re-evaluate your horse's saddle fit after your ride. Check to see if your horse sweated evenly under the saddle pad to make sure your saddle doesn't have any pressure points (dry spots) that would indicate an ill-fitting saddle.

While there are few "official" rules for trail riding, these are some commonly accepted practices that are good to remind ourselves of every once in a while. The word etiquette implies good manners, but the result is a safer experience for you and your horse, and other trail users.

Paprika Grilled Chicken

Grilling Time

#### **Ingredients**

Ingredients for Paprika Baked Chicken Thighs

- 8 chicken thighs bone-in, skinless (8 thighs = ~1 lb. 3 oz)
- 2 Tbsp Paprika Spice Blend for Chicken (recipe listed below)
- 1/2 tsp kosher salt
- 2 Tbsp oil (virgin olive oil or vegetable oil)
- 2 Tbsp chopped parsley for garnish

Paprika Spice Blend for Chicken, Beef (Use ONLY 2 Tbsp for this recipe)

- 4 Tbsp Smoked Paprika
- 3 Tbsp Garlic Powder
- 1 Tbsp Onion Powder
- 3 Tbsp Ground Black Pepper
- 1 tsp Cayenne Pepper
- 3 Tbsp Brown Sugar

#### **Directions**

How to make Paprika Meat Spice Blend for Chicken, Beef

 Combine all the ingredients for the Meat Spice Blend in a small container and shake until well combined. You will use ONLY 2 Tbsp of this blend in the recipe (Note 1). Save the rest for another time.

How to Bake Chicken

- 1. Preheat grill to hot (we add perforated foil to keep flare-ups down).
- Add the 8 chicken thighs (~ 1 lb. 3 oz) to a ziplock or a large bowl, together with 2 tbsp of oil. 2 Tbsp of the Paprika Meat Spice Blend and 1/2 tsp of salt. Mix well, massaging the spices well into the chicken.
- 3. Add the chicken to grill, turning once for 45 to 55 minutes or until the chicken thighs are easily pierced with a fork or knife and juices run clear when pierced. If you have an instant read thermometer, insert it into the thickest part of the meat and it should register 165F

#### **BUSINESS**

Minutes: Gene asked if there were any updates to the March 2021 General meeting minutes. Katie Williams motioned, and Karen Philips seconded to accept the March General meeting minutes as distributed via newsletter. The motion carried.

Treasurer's Report: Barbara Walker provided an update on the account balances. Kathy Stroppel-Holl motioned, and Sandra O'Brien seconded to accept the Treasurer's report. The motion carried. Barbara reported that we received the confirmation letter from the insurance company.

#### **CORRESPONDENCE AND ANNOUNCEMENTS**

**Larry Creek:** Had to post pone the burn at Larry Creek due to bring to wet. Check out the link in Kathy Stroppel email.

Calf Creek: Karen update on the port-a-potty. Bonnie checked with the Ravalli County Health Department and they gave us the go-ahead to put the port-a-potty up a Calf Creek. Contacted the company to have it installed today, April 15, 2021. It will be up at Calf Creek for 7.5 months with a cost of \$90 / month. Karen will be contacting RC Fish and Wildlife and Bitterroot Backcountry Cyclist Group to assist in the cost. There will be a sign that shows who is supporting this service. This will be pumped weekly. Fairgrounds: Dan Maiyo reported out that the Fairground's two arenas are open. You will need to get the lock combination from the Office.

#### **COMMITTEE REPORTS**

Issues: None to report on.

**Projects:** No real project updates at this point, just a reminder to have the members sign up for the project, and please provide an email address. The first project happens on May 22nd up Calf Creek. Brad reported out the manure bin at Larry Creek has been cleaned out. Brad. All the project forms to be sent to Christy. Brad recommends having everyone keep a notebook to make a note of any suspicious activity and let us know about it, including the Forest Service. Evidence was present of trailers backing up to the manure bin and cleaning out their entire trailer. If you see this, please educate the folks that are doing this, if you don't want to please give Brad the license plate # and he will call and chat with them. Lionel to contact Dan

Brandborg on seeing if Betsy would be interested in co-leading the Larry Creek Project.

State Directors: Lionel and Brad gave an update on the State meeting. During the State meeting, it was brought up Wade Murphy, Vice-Chair from the Upper Clark Fork Chapter. He suggested coming up with a Statewide volunteer agreement with the Forest Service, Region 1. This would alleviate some of the work from both Forest Service Rangers District and the BCH Chapters. Some chapters must have three separate volunteer agreements due to working in three different Forests. This was also brought up on a National Level. Two other states are doing this, Washington and Oregon, Region 6. The State has formed a committee to work with Dave Sabo at Region 1 and investigating the policies and procedures used in Region 6 and seeing if they can come with something that will simplify our volunteer agreement. It was brought up that we do not want to lose out on mileage reimbursement. The mileage reimbursement is being discussed at the committee level. There will still be annual meetings and addendums with each chapter and their respective districts. Oncoming Board meetings happening on May 15th at 10 am at the Elks Lodge in Deerlodge. This one may be in person or take place zoom. The next one will be on Sept. 25th at the Elks Lodge in Deerlodge at 10 am. The last one meeting of the year will be in Missoula on Dec. 4th and the place is TBD.

**Membership:** Kathy presented additional secondary family renewal that needs to be approved. **Sandra O'Brien motioned, and Lionel Lavallee seconded to accept the secondary family renewal. The motion carried.** There are 71 memberships and 125 members.

The committee will be going through the donations at that time and will be contacting the folks that donated the items to see if they would like them back. The raffle brought in a little over \$6000. Once the expenses have been taking out the profit will be sent to State BCH of MT. The Convention Committee will let Barbara know the final number.

#### **CORRESPONDENCE AND ANNOUNCEMENTS**

Brad Pollman received an email from Bob Walker from the MT Trails Coalition. The State Trails Advisory Committee is looking for members, like the RAC Committee. This would be in Helena with the Fish, Wildlife, and Parks and the STAC distributes 2.75 million dollars worth of grants. Working on getting someone from the Flathead chapter to be on

the committee. If there is anyone interested, please let Brad know.

#### **COMMITTEE REPORTS**

Issues: None

Projects: Lionel and Dan discussed the projects for the 2021 season. We will be getting the radios from the Forest Service. They are updating it, along with a new radio procedure. Great news from the Forest Service, with the Great Outdoor Act they went from a 2-person crew last year to 10 people this year. Let the Forest Service know if we need any assistance on the trail. Calf Creek, May 22nd - Dan and Bonnie went to the Calf Creek Project Tour with Bob White with the FWP and the whole idea is wildlife enhancement. The plan is to reduce the pines to encourage the native grasses re-established again. We do not need to do anything with the main road, just focus on the trails and replace the damaged Kiosk. Larry Creek, June 12th – Joe Kirkland discussed what the project could be. Looks like the big trees have been taken out when they did the prescribed burn by the Forest Service. Blodgett Creek, June 9th - 11th, Forest Service needs us to have this done for the Selway Bitterroot Frank Church project they have going. The plan is to have members from the local hiker club join us for this project. Coyote Coulee, July 17th - Might need a coleader, Lionel to chat with Betsy Rogan on co-leader this project. East Fork, July 2nd - 5th, Project Leader Katie Williams. The work project days will be Saturday and Sunday to make it to Kelly and Ripple Lake. Two Good Cabin, Aug. 6th – 8th – Ed and Christy Project Leaders. The plan is to clear to Two Good Cabin and then Saturday go to Overwich Falls. Fred Burr, TBD -Dan to meet with Steve Brown on the details. Rock Creek Horse Camp, Sept. 17th & 18th – Bonnie Morgan the project leader. The Forest Service is gathering all the supplies for this project. Lick Creek, fall 2021 - Dan and Lionel to connect with the Darby Ranger. The horse camp needs to be a part of the conversation. St. Mary's Lookout, Mid-July to Mid-Sept – Dan Brandborg project leaders. Dan to talk with the Stevensville Ranger on the schedule. State Director: Lionel discussed the State Board meeting taking place on May 15th. This will be an inperson meeting at the Elks Lodge in Deerlodge at 10 am. Brad discussed the BCHA meeting, the new Chairman Cheri K. from Missouri, new Vice-Chairman is Mark Himmel from Montana, Treasurer Kip Rodriguez from Colorado, Brad Pollman is the Non-Director on the Executive Committee and the Chairman for the Public Lands Committee. The BCHA would like to send a thank you to Kathy for her staying on top of the membership list. If anyone has any questions on the BCHA let Brad Pollman. Brad will be writing an article for the chapter's newsletter. The BCHA Silent Auction was a success.

**Membership:** Kathy reported that the BRBCH has 74 memberships and 131 members.

**Education/Training:** Bonnie discussed the Defensive Horsemanship Demonstration on May 1st. Bonnie wanted to say a huge thank you to everyone that helped, speakers, and volunteers for all that you did.

It was a great day and had several members sign up. Have folks signed up for both morning and afternoon sessions for the Defensive Horsemanship Obstacle session happening on May 8th. Only have a few slots available for the morning and afternoon sessions on May 15th.
