First Aid/CPR certification must be current.

What to Know about Bear Canisters from trailmeister.com

I think we can all agree, keeping bears out of our camps is a good idea. But what to know about bear canisters? What are the best practices?

What we can all agree on is that bears aren't

wanted in camp. A bear rummaging through camp can cut your trip short and endanger both you and the bear. Thankfully, you can avoid that situation by storing attractants properly with a bear canister.

#### What Is a Bear Canister?

Bear canisters – Also known as bear cans or bear vaults – are simply bear-resistant food containers whose main purpose is to protect your food from bears, rodents, and other wild animals. They can be hard or soft and come in a wide variety of shapes and construction types. I used to use bear resistant pannier boxes but have moved on to smaller easier to use solutions such as the Bear Vault.

Bears have an incredible sense of smell and can home in on scents from great distances. Once they smell potential food, their noses lead them straight to the source.

DID YOU KNOW? A bear's sense of smell is 7 times better than a dog's and 2,100 times better than that of a human.

Even though bears are generally afraid of humans, they can become curious if they smell a potential food source. Using a bear canister properly can help you avoid such unwanted visitors. Bears that learn to associate people with food often become dangerous and are ultimately killed or placed in captivity giving meaning to the phrase "a fed bear is dead bear". Keeping bears out of our and garbage is the best way to ensure their survival in the wild and a great camping trip for you.

#### How Do You Use a Bear Canister?

Where you store a bear canister is important. Store bear canisters at least 100 yards from your camp. Make sure that the canister is secure and fully closed. Keeping the canister locked and closed will help to reduce food odors in the area and prevent attracting nearby bears. NOTE: Most bear canisters don't keep all odors locked in but rather make it too difficult for a bear to get to the items of interest and realize any food rewards.

The only time your food and other items should be out of the bear canister is when you're cooking or using them. After use, store any leftover trash in the canister. Practice packing your canister at home before you leave the house to make sure everything will fit in the canister.

Opening a bear canister can sometimes be difficult. After all, they need to protect your food from bears that can weigh up to 800 pounds, if they were easy to open that might defeat the purpose.

DID YOU KNOW? There's an official bearresistant certification process that takes place at the Grizzly & Wolf Discovery Center in Montana. The Discovery Center has a protocol for testing equipment that involves filling a bear resistant container with tempting foods. If the container can keep the bear out for at least an hour it passes as "bear-resistant" and receives its certification.

#### When Should You Use a Bear Canister?

Put simply: If you're camping anywhere there's potential bear activity or any other wild animals, a bear canister is a good idea. Beyond that bear canisters are required in many areas. Know the rules for the area that you're going to be camping in. An example is the Bob Marshall Wilderness in Montana which requires that food and other attractants be stored in a bear resistant manner across the Forest.

The phrase "better safe than sorry" is a cliche for a reason. Even if there are no regulations

where you plan to camp, we recommend using a bear canister to avoid interactions with "minibears" such as raccoons, chipmunks and other critters looking for an easy meal as well as reducing the risk of attracting a larger ursine visitor.

#### What goes in a Bear Canister?

While you may think food is the only thing you'll be keeping in a bear canister, there are a few other things you'll want to store as well. Essentially, anything that has a smell that could spark a bear's interest should be loaded in the container.

This list includes:

Food - Toothpaste - Toiletries - Lip balm - Sunscreen - etc.

## What to Know About Bear Canisters: Basic Safety Tips

- Store the bear canister at least 100 yards from your tent.
- Cook, eat, and clean at least 100 yards from your tent.
- Brush your teeth away from camp and keep scented hygiene products in the canister with your food.
- Be bear aware. Be alert, make noise, and stay on trails.
- Bring bear spray and know how to use it.
- Finally, Leave No Trace!

Most bears avoid people. Most campers never know that they've been near a bear because bears do a great job of avoiding us. If you should see a bear don't panic. Most encounters end with the bear and human departing in opposite directions, without harm to either. The chance of being hurt by a bear is lower than your risk of being hit by lightning and much lower than the possibility of being hurt in a car accident as you drive to the trailhead.

#### BACKCOUNTRY KITCHEN



Pork Chops Smothered in Gravy

#### Ingredients

#### Ingredients for Pork Chops

- 4 pork chops, see notes
- Salt, to taste
- ¼ cup flour
- ½ tsp garlic powder
- ½ tsp onion powder
- ¼ tsp paprika
- 3 Tablespoon olive oil

#### Ingredients for Gravy

- 2 cups chicken broth
- 1 beef bouillon cube or 1 tsp better than bouillon
- 1 teaspoon low sodium soy sauce, can sub Worcestershire sauce
- 1 teaspoon onion powder
- 1 teaspoon garlic powder
- 1/4 teaspoon dried thyme
- <sup>1</sup>/<sub>4</sub> teaspoon dried rosemary
- 1/4 teaspoon dried sage
- 4 Tablespoons Butter
- 4 Tablespoons Flour
- 1/3 cup half and half
- 2-3 drops Kitchen Bouquet, optional

#### **Directions**

 Sprinkle the each side of the pork chops with salt and let them sit out for 30 minutes or so. This will give the salt a chance to penetrate through the meat and flavor it. It will also make them juicier. A light sprinkling is fine as the gravy also has plenty of flavor. You may also choose to cover the pork with saran wrap and pound it with a meat tenderizer. This also helps to make it more tender.

- 2. Meanwhile, combine flour, garlic powder, onion powder, and paprika on a plate and stir to combine.
- 3. Combine the chicken broth, beef bouillon, soy sauce, and seasonings for the gravy. Stir to combine and set aside.
- Pat the pork chops completely dry. Dredge the Pork Chops in the flour mixture just before frying. This gives them a nice outer crust.
- 5. Heat olive oil in a large pan over medium-high heat. Sear 2 pork chops at a time for about 2 minutes per side, until nice and golden. *Optional:* Use kitchen tongs to hold up the pork chops and sear the fat around the outside if using bone-in. Add a splash more olive oil or decrease heat slightly as needed during searing. Set pork chops aside.
- 6. Clear any black remnants from the pan but leave as much brown "fond" as you can, as this will create a more flavorful sauce.

#### Prepare Gravy

- Melt butter in the same pan over medium heat. Add the flour and whisk to combine with the butter. Continue to whisk for about 2 minutes, until you can no longer smell the flour.
- 2. Add the chicken broth mixture + half and half in small splashes, whisking continuously to incorporate. Don't add it too quickly or the roux will break and the sauce won't be as thick.
- 3. Bring to a gentle bubble, then reduce to a simmer, stirring continuously.

- 4. Reduce heat to medium-low, add the pork chops back to the skillet, and spoon the sauce on top.
- Cover and let the pork chops cook for 10 minutes, if possible, use kitchen tongs to flip them halfway through.
- Turn off heat, leave the cover on, and let the pork rest in the skillet for 5 minutes.

Serve with mashed potatoes and roasted carrots or green beans.

Program: Experiences @ the 2021 Iditarod presented by Jan Bullock. Jan is a Veterinary Nurse and has been working for the Iditarod since 1994. This year many people were calling it the Iditarod the "COVID-Rod." There were a lot of changes to this year's race. No big celebrations before and after the race. Had 57 mushers participate in this year's Iditarod. The race is usually 1150 miles but this year was 850 miles due to none of the villages and lodges didn't want the race to come through because of COVID. This year the race started at Deshka Landing in the Susitna Valley. The mushers went out to a far distant place called Iditarod, nothing is there anymore, turned around, and came back. Jan is helping the head Vet with getting all the veterinaries out to where they are supposed to be, paperwork, medications, and whatever else they need. Each group has a bubble they are assigned to and each bubble can not associate with another bubble. At the race, they have the Iditarod Airforce that is made of pilots with their planes. The pilots fly people around to the checkpoints with their gear. Everyone did well in the race and a good majority finished the race. The person that won the race, won it three other times, Dallas Seavey from south of Anchorage. After many COVID tests and hopefully one we will not have again like that. It was the 49<sup>th</sup> Annual Iditarod, a crazy year. Nobody died, no dog deaths, great weather, and lots of snow. It was a year of lots of nothings that didn't happen and wonder whats. Overall it was a successful year for the Iditarod.

"The ability to enjoy the backcountry of Montana surrounding the Bitterroot Valley is much enhanced by what you all do and, while I'm sure many hikers like myself enjoy walking a cleared trail, I just wanted to be one who did something about expressing my gratitude for your efforts." It was decided to handwrite a Thank you card and send it to Stan and Nancy. The card was sent around and Christy will mail the Thank you Card tomorrow morning.

#### **COMMITTEE REPORTS**

**Issues:** None to report on.

**Projects:** Lionel reported out on the projects, please send the reports to Christy. Jan did a quick summary on the project at Calf Creek that is happening on May 22<sup>nd</sup>. Due to the crazy weather, we may not be able to get to the areas we typically do on horseback because of the snow. We will be replacing the posts on the kiosk using a tractor, thank you, Dan! The safety brief will take place at 9 am. Looking forward to seeing everyone there. Dan discussed the next Project - Larry Creek on June 12<sup>th</sup>. New Project Leader is Dan B. Lots of little work needs to be done especially in the Bog area, NE Corner. Hope to see everyone there!

**State Directors:** Lionel and Brad gave an update on the State meeting. Due to the rising cost, we will only see the BCA newsletter hard copy published once a year and the rest will be posted online. The Forest Service is going to start outsourcing the blasting program in 2022. There is some pushback on that to change that policy. Brad discussed more attention at the eBikes at the State level. Our State Chairman is sending a letter to the Senators and Representatives in Washington that represent us in Montana about our position and concerns

on eBike issues. We won't make sure that the eBikes are classified as motorized vehicles since they have an electrical motor on them. There is a coalition of Trail User that BCHA is a member of, that is working on changing the wording of eBikes in the Department of Transportation legislation in funding in Washington that was changing the eBike status. The committee threw the wording out and told them to come back with a wording we all can agree upon. The biggest issue is RTP funding and the rules to get that funding. Working them changing the RTP rules and not change the rules that eBikes are bicycles. Our other issue is Horse Camps being used by a nonequine person. One thing we are lacking is data, so please take some pictures. Document where you are at, did it prevent you from using the facility, did you have to cancel and go home, or go down further to another horse camp area. Who do you connect with? Please contact Sam Cook & Erica Strayer in the Forest Service. Please contact Matt Rosendale about HR #1864 RTP Full Funding Act and looking for a cosponsor. Please ask Matt to co-sponsor this bill his number in Washington is 202-225-3211 and his number in Montana 406-502-1435.

Membership: Bonnie reported out for Kathy. There are 75 memberships and 132 members. Training: Gene thanked Bonnie and her team for all the work they put in for the three Defensive Horsemanship classes. These were well done, well-staffed, and great presenters. Bonnie sent out a huge thank you to all the folks that helped. If any new member would like to complete their Defensive Horsemanship please contact Bonnie. Bonnie went over a reminder on the Firearm Policy deadline is May 31<sup>st</sup>. The First Aid and CPR, Saws Certifications recertifications have been extended another year. The Chainsaw and Crosscut re-certifications can get with the club-designated certifier to get that done on a project.

**Outreach**: Karen has been in contact with RAPP Family Foundation, Bitterroot Cyclist, and the Ravalli County Fish Wildlife Association all assisted in paying for the Calf Creek Port-apotty. There will be a sign stating who is helping with funding the use of the porta-potty at Calf Creek. Susan Slemp is our Social Media Chair for FB. Thank you, Susan!!

**Program:** Karen discussed that Becky Schoefelt will be our program speaker at our June meeting taking place at the Three Sisters Horse Camp. Phil Torgenson will be working on lining up program speakers for the July and August general meetings.

#### **OLD BUSINESS**






