Boulder Creek Summary, July 15-16

Report from project leader Joe Kirkland: We left the trailhead early on July 15th and camped approximately 8 miles in. The USFS had cleared the first 8.5 miles of trail. We cleared all day on July 16th and made it the 2 miles to the pass, breaking into Idaho and then backtracking to the Boulder Lake trail junction where we cleared 1.5 miles to the lake. Bonnie Morgan and Joan Scheffer worked from the trailhead and cleared 41 water bars.

Dan Brandborg, Randy Kappes, Travise Grinnell and I cut and cleared approximately 15 large trees from the trail, cut approximately 60 smaller trees encroaching on the trail, and cleared an additional 40 water bars. The trail is cleared to the pass and the lake, at least until the next storm!

Thank you for everyone's hard work and special thanks to Kathy and Max for preparing the food. It was all delicious and made camping easy! And to top that off, when we got back to the trailhead, Gene and Carolynn Merrell met us with lunch, cold drinks and watermelon. That made the trip complete!

And from food prepper Kathy: Another project completed successfully and safely - congrats to Joe and his crew. Kudos to the water-bar workers - that's a lot of clearing between the upper trail and lower area. I hope we made enough food and no one went hungry! Pictures on BRBCH Facebook.

Summary of East Fork Corral Project, August 2-4, 2022 Report from Project Leader Dan Maiyo: This project was coordinated in part with Jake Long, Recreation Specialist for the U.S.F.S. Darby Ranger District, who supplied all materials from <u>Bouma Post Yards, Inc.</u> Lincoln Mt., for this project. Meat supplied by Hamilton Packing Inc. and other food stuffs were funded by Darrel Reese. Thank-you Darrel!

Approximately 450 linear feet of 6 inch diameter pressure treated posts and 3 inch x 16 ft. long pressure treated rails replaced the existing post and 3 rail fence. The replacement posts were set at the same location where existing posts were removed wherever possible. Approximately 410 linear feet of pressure treated, pre-fitted jack fence replaced the existing jack fence. Existing wood swing gates at the southeast corner of the corral were removed. Two 8-foot steel swing gates were installed providing access to the main corral from the driveway.

On Tuesday afternoon August 2nd BRBCH volunteers met at the historic East Fork Guard Station, located approximately 15 miles northeast from the intersection of Hwy 93 and East Fork Rd., along the East fork of the Bitterroot River, to begin work replacing the old corral. Project leader Dan Maiyo conducted a tailgate safety briefing at 1:00 pm. Bill Slemp provided his skid steer with a post pounder attachment rented from Mom's Rental in Hamilton. Dan Brandborg provided his tractor with forks attached to the bucket to transport posts, rails and jack bundles to strategic locations. Joe Kirkland and Dan Maiyo used chain saws to trim rails and cut piles of logs in the corral. Philp Togenson, Max Stropple, Kathy Stropple-Holl, Gene Merrell, Dan Brandborg, Dan Maiyo, Rich Russell worked up a big sweat fitting and securing the pre-fitted jacks and securing the rails to posts and jacks with big sledge hammers and impact drills to drive in wood screws. We knocked off at 5pm after a marathon day of installing all of the posts, half the jacks, and nearly half the rails. We sat down at the East Fork pavilion for a delicious pulled pork dinner with all the trimmings and desert provided by Caroline and Gene Merrell. Thanks for the watermelon Phil!


A 7:30 am Wednesday morning volunteers were provided hot coffee and a dutch oven mountain-man breakfast consisting of biscuits, patty sausage, scrambled eggs and sautéed vegies cooked by Dan Maiyo. Thanks to Kathy and others for helping with the prep and clean-up work! We began work at 9am. Dennis Hardman, Diane Duffie, Shawn Kern and Leslie Conner-Maiyo arrived in the afternoon to further contribute to the combined effort. Work was completed at 3:30 pm.!!! Dan Maiyo treated the crew to a dinner consisting of BBQ New York steaks and dutch oven fried potatoes and vegies. Leslie provided a brownie cake with whipped cream topping. Thanks to Kathy, Leslie, Shawn and Gene for assisting in the prep work. Most of the volunteers then departed. Dan fixed breakfast for Gene and Philip. Jake Long joined us for breakfast. It is an understatement to express his surprise and appreciation for the work being done so quickly and so well!

NOTE: The supply of ordered rails was short by one bundle. Therefore, the jack fence will need to be completed at a later date. Jake will inform us when they arrive. Installation of the remaining rails should take approximately 5 hours.

I am extremely proud of the work done by this "A" team! The work was projected to take 5-6 days. It was completed in two days! Congratulations to all involved and thank you! More pics an BRBCH Facebook.



BITTER ROOT BACK COUNTRY HORSEMEN (DRAFT) GENERAL MEETING MINUTES, JULY 21, 2022

The July 2022 general meeting of the Bitter Root Back Country Horsemen (BRBCH) was called to order by VP Christy Schram-Duggan at 7:06 pm. The meeting was held at the Coyote Coulee Trailhead. Approximately 30 members were present, with a Board quorum. Travise Grinnell led the Pledge of Allegiance to start the meeting. Guests: Charlie and Autumn from Florence, Ina Jordan from Salt Lake City

PROGRAM

Brad Pollman, Trailer Safety and Maintenance: Brad provided trailer safety and maintenance info he learned from a past member, as well as his experiences with trailers. It is important to stay focused on the hook up - do not get distracted by anything until it's done! He discussed the hitching process with goosenecks and bumper tows, checking the emergency brakes and batteries, checking and changing tires, packing wheel bearings, checking lights, and wear and tear on wood or aluminum floors from urine and mag chloride from the roads (wash immediately). Great presentation by Brad, with good questions from the members.

BUSINESS

Minutes: The June minutes were printed in the Nag News – there were two updates 1) noting that Karen posts photos on Facebook (not Susan) and 2) the correct spelling of Haugh Lake. Karen Philips motioned and Nancy Pollman seconded to accept the minutes of the June 2022 general meeting with noted corrections. The motion carried.

Treasurer's Report: Barb presented the July treasurer's report – there were no updates. **Bonnie Morgan motioned and Leslie Maiyo seconded to accept the treasurer's report. The motion carried.**

CORRESPONDENCE AND ANNOUNCEMENTS

Safety Moment: Christy said with the summer heat to be sure to take water and electrolytes when riding. Set goals to drink enough water. Janice asked what to for horse dehydration – let them drink at every opportunity and check the skin.

Bitterroot Star Article: Karen noted the informative article in the July 13, 2022 Bitterroot Star on BRBCH trail projects.

COMMITTEE REPORTS

Issues: Carol spoke about the Bitterroot Front field trip occurring on July 22, with reservations to the FS. Carol is attending. The FS is proposing an amendment to the 1987 Forest Plan to redefine old growth stands. The public land survey for recreation use in Ravalli County is ongoing. Brad has a copy of the report developed for the survey. The Hog Trough Fire near Skalkaho and the Moose Fire in Salmon are being monitored.

Projects: Christy spoke briefly on the Mill Creek Project, which encountered high water conditions. They were able to clear 16 trees and clean waterbars to within 1 mile of the lake. Ed went back up Mill Creek on July 20 with Steve Brown they noted what needs to be fixed on the trail and cleared 11 more trees to the lake. Kathy said the East Fork/Sign Creek Project was a rousing success and written up in the July newsletter. Christy provided a summary of the Boulder Creek Project, which was cleared to Boulder Lake and to the pass. The St. Mary pack trip on July 14 went very well; the next one is July 28. Dan M spoke about the upcoming East Fork Corral Project. starting on Aug 2 at noon. The cabin is available for folks to use. An email was sent to members. The Fred Burr Project is July 23-24, starting at 8am, to check out the trail above the reservoir for a future work project. Gold Creek Project needs sawyers to hold it -contact Katie Williams if interested.

State Directors: Brad spoke briefly about the recent Monture Rendezvous. BRBCH was well represented.

Education & Training: There is a chainsaw class on July 22-23. There may be more saw classes this fall. New members contact Bonnie for DHS training. Christy spoke about project leader training at the Two Good Cabin Project Aug 19-21.

Membership: There are 89 memberships and 150 members. See Leslie for new member packets and membership cards.
