BITTER ROOT BACK COUNTRY HORSEMEN DRAFT GENERAL MEETING MINUTES, APRIL 18, 2024

The April 2024 general meeting of the Bitter Root Back Country Horsemen (BRBCH) was called to order by President Jan Bullock at 7:01 pm. The meeting was held at the Corvallis Primary School cafeteria. Approximately 31 members were present. There was a Board quorum. Lionel Lavallee led the Pledge to start the meeting. Guests: Steve Rav.

PROGRAM

Steve Brown, Darby/Sula District Ranger - "An Update of Bitterroot National Forest Activities": Steve Brown spoke about several projects around the Bitterroot Forest, including Rock Creek Horse Camp expansion and Mill Creek parking improvements. The Mud Creek project in the West Fork area is on hold, with a decision on Phase 1 anticipated in September 2024 for work to start in 2025 and Phase 2 the following year. The Gold Butterfly project in the Sapphires has treatments to the north and south of Willow Creek, and improvements to the Gold Creek Campground. The Bitterroot Front project covers from Lolo to Conner. Treatments will mitigate for fire risk. The ultimate goal is to use fire to control the fuels. No clear cuts are prescribed. Bear and Gash Creeks will be the first areas worked. The BR Front project will go over many years. The Eastside project goes from Florence to Sula/East Fork. The goal is to improve wildlife habitat. The Fuel Breaks project runs through areas that burned in 2000; the canopy can only be reduced by 50%. Project maps are available online. There will be a food storage order on the forest soon, with public education being done first. Bear boxes/panniers are a good way to store food on projects.

BUSINESS

Minutes: The March minutes were printed in the April Nag News. Bonnie Morgan motioned and Lionel Lavallee seconded to accept the March minutes as published. The motion carried.

Treasurer's Report: The April treasurer's report was provided. **Ed Bullock motioned and Karen Philips seconded to accept the April Treasurer's report. The motion carried.**

CORRESPONDENCE AND ANNOUNCEMENTS

Intro of New Officers and Board Members: Jan introduced the following: Dan Brandborg is the new VP, Kathy S-H and Karen Philips are co-secretaries; and Lionel Lavallee and Cherie Barton are new Board members.

Thank You: Barb thanked Diane Duffie and Dennis Hardman for their service and leadership.

Fairgrounds Play Day: Dan M spoke about the play day on May 5 at the fairgrounds. Folks can introduce their horse to trail etiquette. A fairgrounds release form will need to be signed. He also noted that the Nag News has a unique article on disposing of dead horses for folks to read.

Safety Moment: Be careful of putting your horses on spring grass; mornings are better to graze. Be aware of how much water horses are drinking out of cold streams.

COMMITTEE REPORTS

Grants: Presented by Dan B. Will start pursuing grants in the fall. BRBCH was not selected for the REC POC. We can apply again next year.

Projects: Presented by Dan B. The signup sheet will be available soon on the website. The Fred Burr project may still get some MCC crew support from the FS. A weekly trail report will be available as the FS crews finishes clearing. Form 301B needs to be signed if anyone wants to work on a FS trail project (Travise started a copy to sign at the March meeting). Copies of the FS Volunteer Services Agreement are available.

Issues: No report – deferred to Steve Brown's talk.

State Directors: No report. The last founding father of BCH, Roland Check, recently passed away.

Education & Training: Presented by Bonnie. The May 11-12 Rock Creek Horse Camp (at Lake Como) signup was passed around. Sat dinner and Sun breakfast will be provided. Workshops and trail rides are planned, as well as trailer tours. A women's bike retreat will be nearby at the Three Sisters group site, so they will be sharing the woods with us. They'll bike south of the lake while trail rides will be on the north side. Be sure to bring water for your horses as the campground is dry. Dogs must be on a leash in the campground, and do not bring them on the group ride. Twelve folks were CPR/FA trained on April 13 with Connie Long. The next CPR/FA training is April 20 with Jan.

Membership: There are 71 memberships and 113 members. **Outreach:** Presented by Karen. She will contact the groups that helped pay for the Calf Creek toilet in the past and others who might be willing to chip in.

Program: Presented by Monica. Jerry Fowler will speak about reining in May.

Absent were VP Diane Duffie, Secretary Judy Posey, and Director Dennis Hardman. There was not a board quorum. Everyone led the Pledge.

BUSINESS

Treasurer's Report: Barb provided the account balances. There were no questions. Brad appreciated the quarterly report Barb emailed to the Board.

Minutes: No report.

CORRESPONDENCE AND ANNOUNCEMENTS

Smoke Elser's book presentation is this evening. Dan wants to get to the presentation early since the Missoula book presentation was well attended, so he would like the meeting to be over by 6:30.

COMMITTEE REPORTS

Projects: Presented by Dan B. Waiting on the FS to get back to him for timing on Fred Burr project; depends on availability of their blasters. Dan M has the East Fork cabin for another weekend to continue wire cleanup there. Need a project leader to lead a trail clearing project around the same time -East Fork, Clifford Cr, etc. Someone put their hand up to lead ing. She will check if he's available for the May campout. it. Brad spoke to Caleb (Stevi District) about the Larry Creek Ed D noted the toolshed equipment has been checked, and project (on June 1); Caleb is putting in a special order to grade the road. A couple waterbars will be added on the up-

Grants: Presented by Dan B. The Wilderness Lands Grant around 10 am. came up and closes this week; could pursue it next year. Brad provided a short update on that grant - they never know how much funds they'll have, depends on Washington's funding. Jan noted the Ravalli Electric Co-op Power of Change sent a letter that BRBCH was not selected for funding the Calf Creek porta-potty. She notified Rebecca Mowry that BRBCH will not put in a potty unless other groups come through with funding.

State Directors: Chuck spoke about the Selway Bitterroot Frank Church Foundation's Youth Wilderness Expeditions in 2024. Older teenager trips - July 16-19 and July 30-Aug 4 in wilderness areas. Younger teenager trips - Aug 13-16 and June 18-23 in the Bitterroot NF. The SBFCF pays for all expenses. Online applications are due soon. Brad provided an update on the National Convention in Casper, WY. A balanced Continued next page budget was presented. Light on the Land (LOTL) (copyrighted by BCHA) was introduced, with info on it available for free on the website (as opposed to Leave No Trace, developed by BCH but now owned by another entity). LOTL

info is unique to different regions around the US. FS buy-in is being pursued. The National live & silent auctions raised ~\$29K. A signed crosscut cookie's auction money was earmarked for youth grants to chapters. The bicycle issue was discussed more in-depth. Brad was elected to the National Executive Committee. Travise was awarded a one-handled crosscut saw - he was interviewed during the State Convention for this award by the man who builds the saws. The man takes old saws and re-works them.

Membership: Renewal memberships were discussed and will be approved at the next Board meeting. There are 70 memberships and 112 members.

Program: Steve Brown will present on an update on FS activities at the April general meeting.

Constitution: Presented by Dan M. Working to separate constitution from by-laws, with a target date of Nov to complete the updates and. Next meeting is April 14.

Education & Training: Presented by Bonnie. DHS obstacle class is April 6. DHS obstacles will be put up April 5 at C-Max. The afternoon class will help take them down. FA/CPR class is April 13, taught by Connie Long. A date will be set for another class later in April. Saw training is coming up in May -Brad spoke more about that. Bonnie will contact Dan and Travise if someone who is not on the list wants training. May 11 is reserved for the Lake Como campout. Nancy is making dinner. Dan M will pick up the "Chuck" wagon to bring to the

NEW BUSINESS

Diane Duffie and Dennis Hardman submitted their resignations as VP and Director, respectively. They will remain as members. Jan will note the need for another Board member and VP in her next president's message. Judy (Secretary) is indisposed for medical reasons - Jan will talk with her and see if she wants to resign for now. Mark asked if there were runners up from the Nov election who might be interested in filling the open positions. Bonnie will call these folks and see if anyone is interested; if anyone knows of someone interested in a position, have them call her. Dan M noted Art V, Sec 5 delineates how open positions are filled by the Board.

Art VI, Sec 6 was brought up. There wasn't a quorum to make a decision. Travise was requested to submit a hard copy of his email. Dan noted there were lots of good folks in the group, and hopefully the chapter can get through this without losing anyone. Joan does not have a bias either way and is unfamiliar with the cause of the issue, so she doesn't feel she can vote on it. Brad discussed the overload of emails he received, and that he will address things in a meeting and not via email. Joe noted the amount of 2023 volunteer work hours that Christy recorded for the chapter, and that members provide a lot of valuable work. He doesn't feel the Board should referee individual disputes. Mark discussed the Missoula BCH and how a comment would cause a person to guit. He noted we need to be honest but kind and know

that words can hurt. We are all important to each other; if someone screws up, discuss it and move on. Carol would like to respond, but without a quorum nothing can be done. A mediator was suggested, but it would not have value. Ed D spoke about the issue causing strong emotional distress. There was further discussion about folks behaving in a professional manner and controlling their emotions (similar to controlling emotions when working with a horse).

Education & Training: Bonnie reported that 28-30 people have signed up for the May 11-12 campout. She will send out an email to members. Attendees need to bring water and weed seed free forage. Dan M will bring the "Chuck" wagon to the event. Nancy will prepare Saturday night dinner, Kathy will cook Sunday breakfast and Virginia DeLeo will help with all meals. Trail rides at different times will be led by Julie, Bonnie, and Jan. A women's bike group will be camped across the road at the 3 Sisters Group Camp. At this time no additional first aid classes are scheduled. Travise and Ed D can renew cross-cut certifications, but members need to contact them if they want to be renewed on a project. 

TRANSITIONING HORSES TO SPRING PASTURE (Editor's Note: reprinted from April 2023 Nag News) Krishona Martinson, PhD, University of Minnesota

- 1. Spring grazing should be introduced slowly and delayed until grasses reach 6 to 8" in height to optimize health of the horse and pasture.
- 2. When pastures reach 6-8" inches, begin grazing for 15 minutes, increasing grazing time by 15 minutes each day until 4 to 5 hours of consecutive grazing is reached. After that, unrestricted or continuous grazing can resume. Feed horses their normal hay diet before turning them out to pasture during the first several grazing events of the season to avoid rapid intake of pasture grasses.
- 3. Change feedstuffs gradually. There are significant differences between hay and pasture forms of forages. Dried hay is approximately 15% moisture content, fresh pasture is 85% moisture. Horses are a fermenting herbivore that relies extensively on the microbes present in its gastrointestinal tract to be able to process forages. The microbes are a mix of different organisms that work together. If the foodstuffs the microbes are utilizing change suddenly, there may be to little time for the microbial populations to adjust to the change. Instead, large numbers of them die, while others flourish, setting up a situation where toxins may be absorbed by the horse, resulting in digestive dysfunction and possibly colic. A gradual change from one feedstuff to another provides enough time for the microbial populations to adjust.
- 4. Manage pastures to reduce the chance of laminitis. Laminitis is a painful, disabling, common, and costly equine disease that has many causes. Annual incidence of laminitis in the U.S. is reported to be 2%, but rises to about 5% in the spring and summer. Nearly half of all reported cases in the U.S. occur in animals at pasture. During photosynthesis, green plants produce simple sugars. When sugars are produced in excess of the energy requirement of the plant for growth and development, they are converted into storage, or reserve carbohydrates. Storage of carbohydrates is commonly seen during the rapid growth of spring. The vegetative tissues of cool season pasture grasses (i.e.timothy, orchard grass, brome grass) accumulate fructan as a component of their reserve carbohydrate., which is stored in the stem until required by the plant as an energy source. The sum of simple sugars, fructan, and starch comprises the nonstructural carbohydrate (NSC) fraction of the plant. There is some evidence of association, and even stronger evidence of causation between laminitis and rapid intake (and total intake) of NSC. Furthermore, administering high concentrations of fructan to horses has resulted in laminitis.

- 5. In European studies, fructan concentrations were highest in the spring, lowest in the summer, and intermediate in the fall. Because horses are selective grazers they find feedstuffs with elevated sugar content highly palatable. Avoiding or restricting grazing in the early spring can reduce the chance of rapid NSC intake and laminitis. Seek veterinarian approval before grazing horses susceptible (or with previous episodes of) laminitis as some horses cannot tolerate any grazing.
- 6. Pasture health. Pasture grasses need sufficient growth before grazing is allowed. Photosynthesis occurs mainly with the leaves of the plants. If the leaves are grazed too early (prior to 6" tall) or too often, plants can lose vigor, competitiveness, and root structure due to the lack of photosynthetic ability. This will lead to eventual die back and overgrazed areas being replaced by noxious weed species. Grazing should cease when forages have been grazed down to 3 to 4". Grazing can resume when grasses regrow to 6 to 8". 2 to 3 acres of well managed pasture can provided forage needs for one horse from spring to fall.

DUTCH OVEN OMELETTE

Ingredients:

- 2 dozen X-large eggs
- 2 cups cubed ham or pork, crumbled bacon strips, country sausage, sausage link pieces or left over steak from the night before (or some of, and/or all the above)
- 1 cup each diced onions & bell peppers
- 1 cup sliced mushrooms
- 1 to 2 cups chopped fresh tomatoes
- 2 cups shredded cheddar cheese (or whatever suits your fancy)
- 1 cup milk
- 1 stick melted butter
- 1/2 cup canola or olive oil

Coat inside of DO with oil. Break eggs into DO, add milk and whip until thoroughly mixed. Stir in the rest of the ingredients except on cup of cheese. Cover and place on heat source. Low and slow is best.

Initial phase of cooking, stir frequently as eggs start to cook. As eggs set up with cooking, lower heat until fully cooked. In last few minutes before serving, spread last cup of shredded cheese over omelette, replace lid and let melt.
