Hello, Fellow Members -

Hope to see you at our July general meeting at Larry Creek this week. I encourage you to come early and take a ride or hike before the meeting.

I'd like to talk to you about a donation from BCH to the National Museum of Forest Service History in Missoula. They are well on their way with construction.

There was a presentation at our state board meeting last September, and Smoke Elser brought it up again at last month's state meeting. A committee was formed, with Mark Himmel heading that up. This was discussed at our chapter's board meeting this month; the consensus was to move ahead and seek donation pledges from our membership towards a contribution from our chapter.

I spoke with Mark and starting in July he will be sending out weekly reports as to how the pledges are coming in. Several chapters' pledges have been received, so Montana is already halfway to its \$10,000 goal. The plan is for Montana to challenge other BCHA states to donate and get to a point where we will have a display showing how BCH partners with the Forest Service and the

#### **COYOTE COULEE PROJECT**

Saturday, June 21, 2025

The second project of the season is at Coyote Coulee this Saturday, June 21. Please arrive to be ready to go with saddle stock by 8:15. The safety talk for everyone will start promptly at 8:45am. The project lead this year is Julie Schram.

**Directions:** Drive south from Hamilton on Hwy 93. Turn right (west) onto Lost Horse Road. Drive 2.4 miles to a posted junction with FR 496. Take the right fork onto the gravel road and drive a couple hundred yards to the trailhead parking on the right. There is an outhouse.

The 1st loop has the most waterbars (52!), which will be handled by hikers and riders. Another group of riders may go out to the connector (7 WBs) then on to the 2nd loop (25 WBs) if time permits. We'll do as many as possible!

Lunch will be served starting around 12-1pm. Lunch will be available for those coming back later until about 2. Remember to bring water, a snack for the trail, sun protection, rain gear, and a chair to relax in after your hard work.

It is asked that no dogs are brought on this project.

There are a couple trees down across the trail and some that need to be taken back more to make them easier to pass by for safety reasons.

**What to bring?** Your favorite tool (shovel, rake, hoe, Pulaski, loppers, nippers, handsaw, etc.) that work.

# Crazy Creek/Twogood Cabin Project recap

On Saturday, May 31st 20+ people showed up. Diane and Dennis provided a yummy breakfast. Thank you!

There were 14 people working on the Horse Camp facility, and 7 people rode into the cabin with 7 riding horses and 3 pack animals.

We removed 3 trees on the trail and one leaning tree.

<u>Camp Crew</u>: Went to each campsite and evaluated what needs to be improved. Used a weed eater on each side of the road through the entire facility. Brushed out the edges, around each tie area, and each campsite. Several piles of debris need to be removed. The biggest priority is Fire Mitigation at the Horse Facility. Mark Wright chain-sawed some trees that were in the way of the camp sites.

Twogood Cabin: Got on the trail @ 9:45 am and returned to trailers about 5:15 pm. Packed out expired food and trash; tested the pump with a bleach/ water mix, and it worked great for us; sprayed the floor, walls, beds, table, and all surface areas in the cabin and outhouse with the bleach/water mix; swept the floor, cleared all cobwebs out; and cut and stacked firewood.







#### **Larry Creek Project Recap:**

Thank you to the 22 members, which included 2 riders and 4 pack stock, who turned out on National Trails Day, June 7, to work on the Larry Creek project.

As a reminder, the Grant Committee applied for and received a \$750 grant from BCHA towards this project. These funds were used to build a new mounting block, provide a gravel base around it, and purchase materials for 10 new water bars.

With the help of the Stevi USFS District, it was determined which waterbars needed physical maintenance or where new installs were required. Water bars were prepped and delivered prior to the day of the work project. Eight new water bars were installed, with at least one rock water bar created, while others were lengthened to accommodate the ever-widening trails. Here's a general overview of what was accomplished: cleaned up trailhead and parking area, cut out and cleaned up 4 trees, installed 4 new water bars, cut out and brushed back trail with bridges, cleaned waterbars and bridges of duff and debris, refinished the Bitter Root BCH recognition sign, built a new mounting block, performed level 1 maintenance on 11.25 miles of trail. Brad and Nancy fed the crew before sending all on their way home.

The following week Brad emptied the manure bin. He still has a bit more he'd like to complete before calling it quits on this project this season: install additional new water bars and cut up the rest of the tree at the trail-head.

And last but definitely not least -- kudos to Barb and Pam who set a table up near the kiosk to share the BCH mission. This resulted in new memberships, some nice donations, and plenty of laughs all around.

Thanks again to all! May all our future projects go as well as this one!









#### BITTER ROOT BACK COUNTRY HORSEMEN DRAFT GENERAL MEETING MINUTES, MAY 15th, 2025

The May 2025 general meeting of the Bitter Root Back Country Horsemen (BRBCH) was called to order by President Brad Pollman at 7:04 p.m. The meeting was held at the Corvallis Primary School cafeteria. Approximately 33 members were present. There was a board quorum. All members led the Pledge to start the meeting. There were no guests

#### **PROGRAM**

Krissy Ferriter, Volunteer Program Director, Selway Bitterroot Frank Church Foundation: Kathy introduced Krissy who provided an overview of what their organization does, partnering with the Forest Service and Back Country Horsemen. There are multiple lookouts in the SBFCF area of maintenance. SBFCF was established in 2006 and since then their area of operation has increased. This year they have trail crews, an experienced pool of workers, wilderness ranger fellowships, volunteer stewardships, a youth program, and a river program. Volunteers serve as fire lookouts. St. Mary's Peak Lookout history: In the 1800's priests and parishioners hiked up the mountain from the Stevensville mission. In 1934, the 50'ft tower was built offsite and hauled up the mountain. Wind destroyed the original tower in 1951, and it was replaced with the classic L4 roof lookout without the 50' tower. It is now on the National Registry of Historic Places. At 9,300 feet in elevation, an average of 1,200 people hike there every year. FS requested SBFCF take over lookout staffing, protection and maintenance, visitor education, and delivery of supplies. SBFCF's main goal is increasing wilderness stewardship and public education. Their newer program is "Trailhead Ambassadors" who provide information to trail users. Their stats since 2009 through 2024: 45 volunteers, 842 days, 7300+ volunteer hours. The Sharrott Creek fire burned part of the trail and closed the lookout in 2024. BRBCH volunteers help SBFCF by packing in supplies, tools, and all kinds of gear to lookouts or trail projects; this totaled 140 hours of pack time in 2024.

#### **BUSINESS**

Minutes: The April minutes were printed in the May Nag News. There were no corrections. Mary Odell moved and Christy Schram-Duggan seconded to accept the March and April general meeting minutes as printed. Motion carried.

**Treasure's Report:** Elaine presented the May treasurer's report. Discussion followed. **Travise Grinnell moved and Bonnie Morgan seconded to accept the April and May treasurer's report. Motion carried.** 

Correspondence/Announcements: Brad circulated a getwell card for Mack Long, who fell off his truck tailgate and injured himself. Kathy noted there are 6 slots to fill on the coffee/hot water signup sheet for the Sept-Dec meetings and passed around the signup sheet. She circulated the 301B volunteer forms for project volunteers to sign. Christy circulated background check forms for all people who plan to work at the fair. Brad reported that the payment we receive from the fair has increased to \$4500.

#### **COMMITTEE REPORTS**

**Grants:** The \$750 grant we received from BCHA will pay for water bars to be installed at Larry Creek.

**State Directors:** Brad/Ed/Chuck: Ed said the next state meeting is Saturday, May 17, at Deer Lodge. Attendees will discuss the regional volunteer agreement to make sure all volunteers are covered for liability.

**Training:** Bonnie circulated a sign-up sheet for saw training. Recerts can be done at the Lost Horse Rental Cabin and Bear Creek Trailhead. Bonnie thanked Ed and Christy for their packing clinics. They are doing great work. Ed and Christy thanked Dennis and Diane for the use of their barn for the class. Ed asked clinic members to consider helping at the first project at Crazy Creek on May 30-31; it will be a good opportunity to practice what they have learned.

**Membership:** Barb reported that we have 66 memberships and 104 members.

**Outreach:** Karen said the portable toilet was delivered to the Calf Creek WMA trailhead before the opening at noon today. She attached a poster inside the toilet that shows the groups providing the service, including Bitterroot Back Country Cyclists, Rapp Family Foundation, Ravalli County Fish and Wildlife Association, and our chapter. Thanks go to Barb Walker for facilitating the toilet delivery and to Barb and Elaine Driskell for handing the payments. There is a different system for advertising our FS projects in the media now due to new FS rules on what can be sent to the media. The FS can only issue press releases dealing with safety or health impacts. We will use our FB page to let the public know when and where we will be working on trails. That information can then be shared by the FS to their Discover Bitterroot FB page. **Fair:** Christy said fair dates are 8/27-30. There aren't major changes, and the fair schedule information is on our website. People are already signing up to work. Christy recommended that members sign up now to get the shifts they want. She has contacted her 2024 managers. Her son John will be here as our tech person.

**Projects:** Ed provided 301B forms and thanked project committee members for their hard work in getting through challenges this year. Nancy will add names of volunteers to the website list of certifications as they sign the 301B form. Projects prior to the June general meeting include Crazy Creek/ Twogood Cabin on May 30-31; Christy Schram-Duggan and Ed are project leaders. Volunteers meet on Friday for breakfast and safety meeting, with main work on Saturday. Larry Creek is June 7, National Trails Day; Brad and Mary Odell are project leaders. Barb will set up PR tables, members will install new water bars, and John Dorman (FS) will provide trail construction information. Covote Coulee is 6/21; Julie Schram and Travise are project leaders. Volunteers will do basic maintenance. East Fork barb wire removal is 7/11-13; Dan Maiyo and Chris Carrera are project leaders. Our past years' work on this wire removal has been greatly appreciated by the FS. Cabins, one electrical hookup, and corrals are available for members. Boulder Creek Project is July 18-20; Chris Carrera and Dan M are project leaders. Volunteers will clean up the trail head, parking area, and the trail.

Absent were Directors Julie Schram, Christy Schram-Duggan, State Director Ed Duggan (all at son John's graduation), and Alt. State Director Chuck Miller. There was a Board quorum. Committee chairs and members present: Bonnie Morgan, Dan Maiyo, and Dan Brandborg. All led the Pledge.

#### BUSINESS

#### CORRESPONDENCE AND ANNOUNCEMENTS

#### **COMMITTEE REPORTS**

Membership: One new membership was presented, a hiking friend of Kathy who is interested in working a trail project. Kathy Stroppel-Holl moved and Barb Walker seconded that we approve one new member. Motion carried. There are 105 members and 67 memberships. Barb will have a promotional table for the chapter at the Larry Creek project on June 7, National Trails Day. She designed new BRBCH business cards for our members to share with the public.

**State Directors:** Brad discussed the BCHMT meeting held on May 17. Chris Nygren, Gallatin Valley BCH, is taking over Chuck Miller's position on the Issues Committee. FS Carol Hennessy, with FS Region 1, said BCH "is absolutely covered for liability on projects," as stated in the Volunteer Service Agreement.

Sponsorship opportunities for BCHA: The National Museum of Forest Service History, a 501c(3) nonprofit organization (independent of the USFS), is fundraising for the design and production of an exhibit on the historical role of BCHA's work with the FS. The National Conservation Legacy Center will house FS artifacts and exhibits, and will be located past the Missoula Airport just beyond the Smokejumpers base. BCHMT is going through a pledging process asking for donations from members. The Board discussed asking our members to pledge to this cause on behalf of our chapter. The Board heartily endorsed supporting this exhibit and presenting the pledge process to our members.

The BCHMT Rendezvous is at Gold Creek, MT, June 27-29, near the Beck Ranch. Lots of horse trailer parking and camp sites are available. Monture Creek is proposed for the 2026 Rendezvous/Trail Project. Mark Smith will serve as our liaison for this event.

Brad used Larry Creek grant money to buy and drill water bars. John Dorman, Stevensville District Recreation Specialist, is coordinating with us. Brad built a new mounting block that will be installed and our "maintenance" sign will be refurbished by Dennis. Be there for the safety meeting by 8:45. Brad met with Mark Smith at the SO who gave us several Silky saws and lots of other equipment.

**Fair:** Christy sent an email that sign-ups are going well.

**Public Lands/Issues:** Brad reported on a couple of issues: a Public Lands Caucus supported by Zinke is a good thing. It has been reported that Daines is working with Mike Lee to

negotiate about selling public lands. Randy Rasmussen is assisting Mack Long in writing a letter to Daines saying BCHMT doesn't support this.



#### Prepare for a Barn Fire

STEPS INVOLVED IN PREPARING YOUR FACILITY AND HORSES FOR YOUR WORST NIGHTMARE.

#### Know who to call

#### 3. Consult ahead of time with the fire department

Contact your local fire department and ask for a safety check list. Prepare your horses with the look and smell of fire suits, helmets, flashing emergency lights and fire vehicles.

#### 4. Fire Drill

Pick a day when your boarder(s), horse sitter, and any appropriate neighbors are available. Time yourself. Take turns going through the steps, practice the motions, debrief. What went right? What corrections should be made? Make a video and review the drill.


