

BITTER ROOT BACK COUNTRY HORSEMEN DRAFT GENERAL MEETING MINUTES, NOVEMBER 16th, 2025 PROGRAM

The November 2025 general meeting of the Bitter Root Back Country Horsemen (BRBCH) was called to order by Vice President Dennis Hardman at 7:05 p.m. The meeting was held at the Daly-Leach Community Room. Approximately 33 members were present. There was a board quorum. All members led the Pledge to start the meeting. Guests: Robert Wallace from Florence, Pam Ristad's co-worker.

2026 ELECTION

Bonnie Morgan conducted the election process for President, Vice President, Secretary, Treasurer, four Directors for 2026-2027, State Director for 2026-2027, and the 2026 Alternate State Director. Ballots were completed via email, mail, or in person at the meeting. Per election protocol, Bonnie asked for nominations from the floor three times for each position. The ballot results are as follows:

For President, Diane Duffie is nominated. There were no nominations from the floor. **Ed Duggan motioned and Kathy Stroppel-Holl seconded that nominations for President be closed. Motion carried.** After tallying the ballots, Diane Duffey was voted in.

Present were President Brad Pollman, Vice-President Dennis Hardman, Treasurer Elaine Driskell, and Co-Secretary Karen Philips; Directors Diane Duffie, Mary Odell, Joan Scheffer, Julie Schram, Barb Walker, and Mark Wright. Absent were co-secretary Kathy Stroppel-Holl, directors Chris Carrera, Lionel Lavallee, and Christy-Schram-Duggan, Director Ed Dug-

gan and Alt. State Director Chuck Miller. There was a Board quorum. Committee chairs and 2026 elected Board members present: Pam Ristad and Bonnie Morgan. All led the Pledge.

BUSINESS

Minutes: The November 2025 Board minutes were published in the Nag News. There were no changes. Mark Wright motioned and Dennis Hardman seconded to accept the November minutes as published. Motion carried.

Treasurer's Report: Elaine Driskell provided account balances for CDs, checking, and savings. Dues for state and national are due to the State BCH by Dec. 13. **Mary Odell motioned and Julie Schram seconded to accept the December treasurer's report. Motion carried.**

COMMITTEE REPORTS

The members on the list were discussed. **Julie Schram motioned and Mary Odell seconded to accept the new and renewal members. Motion carried.** We have 72 memberships and 112 members. The December 18 meeting membership drive/door prizes include many great items from a variety of supporting businesses. Several members are recovering from surgeries and illness.

State Directors: Brad reported the next state meeting is on Dec. 13, 10 am to about 3 pm at the Missoula County Fairgrounds. The Christmas party, hosted by Missoula BCH, is at 6:30. Topics at the meeting will include discussion of public lands and cutting costs of attending the national meeting. Mark requested that our $50^{\rm th}$ anniversary be included in the schedule at the state convention. Brad said our chapter was instrumental in forming the national organization. Julie and Helen Engle are starting to view old photographs to add to our celebration.

Training: Bonnie said we will have two trainings at C-Max with one demonstration day and one obstacle course day with two sessions, likely in April. The third training could be at Rock Creek Horse Camp, possibly combined with a project there and a trail ride. Submit ideas to Bonnie, especially ways to get more people involved with hands-on practice. First aid classes are Feb. 1 and Feb. 28. Adam Washback, regional saw coordinator, will be contacted to help with certifying our saw trainers. This is a potential problem if there are no longer any FS regions. Projects: No report.

Grants: Brad spoke about grants from the Montana Trails Coalition, FWP's RTP grants and other grant possibilities. But we need to get our ideas organized in order to apply for these grants. Brandi can write the grants but she needs project ideas. Crazy Creek Horse Camp (including forest thinning around it) and East Fork Trailhead are two examples of sites that need help. Brad will take over Long Term Planning in 2026 and that committee's work can coordinate with the Grants Committee. One of his goals is to get ideas from all trail riders in the valley.

Public Lands: Brad reported on a new bill being introduced in Congress: the Roadless Area Conservation Act (RACA). Sen. Daines responded to Brad's inquiry regarding this bill and said he would keep Brad informed. Brad said that attacks on public lands are coming from all directions. An upcoming issue in eastern states is that mountain bikes are overrunning all other users.

Budget: Karen reported for Earl and said his committee will get going once he recovers from his pacemaker implant surgery. He will call committee chairs asking for their budget needs.

Audit: Barb/Kathy/Nancy are on the committee and will meet in January.

Constitution: Next meeting is Sunday, Dec. 14, 2:30, Stevensville Fire Hall (on Willoughby Lane) on bylaws.

Program: Dec. speaker is Grace Gauthier, Certified equine massage therapist, who will discuss equine massage. Jan. speaker: Q DeHart on BLM's Wild Horse & Burro adoption program.

OLD BUSINESS

Election: As Barb was elected to be VP, her unexpired Director's position needs a replacement. Brad will contact two possible replacements and will send out a ballot to the board.

Pantry Partners Food Box Pack Overview: Barb reported that the food box pack on Nov. 21 was a success. Eighteen members participated.

50th **Anniversary Celebration:** Diane suggested April or May for possible dates for a get-together and possible locations, ranging from restaurants to pot-luck sites. Brad suggested locations that are easily accessible. Joan volunteered to help on this committee.

NEW BUSINESS


January Board Meeting Date Reminder: Brad noted the meeting date is Friday, Jan. 2nd due to the holiday on Jan. 1

General Meeting Numbers Trend/Phone Numbers in Newsletter: This issue will be added to the Jan. 2 board meeting under Old Business. FYI: Dan M had requested numbers on the trend of attendance at the general meetings. Kathy noted that for 2025, attendance has varied from a low of 19 to a high of 35, with an average attendance of 27. For 2024: low of 15, high of 46, average 29. What is a Hoof (Shoe) Boil?

plained that a hoof or shoe boil was developing on his horses that are not shod. right elbow. I immediately took steps to successfully arrest the condition. A thick bed of shavings in his pen provided him with a soft comfy bed lay down in, and helped alieve the situation.

Causes. When a horses lays down, the area around the heel or bulb of the hoof may frequently contact and irritate the elbow joint area.

Shoe boils, also known as olecranon bursitis, capped elbows or elbow sores, are a common condition seen in horses. They occur when the horse repeatedly puts pressure on its elbow joint, often when lying down for extended periods on shallow bedding or with long-heeled horseshoes. This prolonged pressure causes inflammation and swelling, leading to the formation of a fluid-filled sac beneath the skin, typically located on or near the point of the elbow.



While most cases of shoe boil develop gradually and are relatively painless, sudden injury to the elbow or infection can cause acute shoe boil, which may result in pain, heat in the area, and even lameness. Many cases resolve on their own once the underlying cause is identified and addressed. Recurrence of shoe boils is common, so the condition often requires ongoing management.

The term "shoe boil" originated from the idea that these swellings were caused by pressure from the horse's

> Diagnosis involves physical examination and imaging to assess swelling and rule out deeper injury. Treatment includes rest, cold therapy, aspiration, corticosteroids or surgical removal in severe cases. Prevention focuses on deep bedding, proper hoof trimming and padded elbow boots to reduce pressure.

> Preventing Further Trauma. The first and most important step in shoe boil treatment is preventing additional irritation to the elbow area.

Increase Bedding. Adding deep, soft bedding helps cushion your horse's joints while lying down.

Use a Shoe Boil Boot: Shoe boil boots (also known as donut boots) wrap around the pastern to keep the hoof from contacting the elbow. They're one of the most effective tools in your tool kit. Consult your farrier to adjust or shorten long heels, which can aggravate the elbow when the horse rests.

Note that Spot's right leg is tucked underneath itself. It is in this position that the heel of the hoof will come in contact with the elbow.

Chicken and Dumplings

This world famous recipe has been handed down through generations of my family. I give specific credit to my mother, Lucy Maiyo for inspiration to carry on the tradition.

INGREDIENTS:

- 1 large whole chicken (or canned chicken if you are in the backcountry)
- 3 or 4 carrots, peeled and chopped into not less than 1 inch long bits
- 1 onion, peeled and coarsely chopped
- 3 or 4 stalks celery, coarsely chopped into not less than 1 inch long bits
- 2-3 cloves garlic, peeled and minced
- 1 Tbs. salt to taste
- Pepper to taste
- 1 Tbs. dried basil, crumbled (optional)
- 1 or 2 large Tbs. powdered chicken bouillon or to taste
- 4, 5, or 6 fresh eggs, depending on how many dumplings you want to cram into the pot
- 1 Tbs. baking powder
- 1-2 cups of white flour

DIRECTIONS:

• In a 5 qt. or larger pot, (or dutch oven) boil the bird until the meat is ready to fall off, remove from the pot and then de-bone the dude into bite size pieces. Discard the

skin. Set the pot of broth aside.

- Crack the eggs into a large bowl and beat with a fork, mix in the baking powder and add a few pinches of salt to taste. (You can add the basil at this time if you wish)
- Gradually begin adding flour to the mixture and folding with the fork, very similar to making homemade noodles.
 You want the batter to be somewhat firm, but not wimpy either.
- Bring the pot of broth to a low boil and add the chicken bouillon, vegies and chicken. (Note: You may need to add more water to accommodate the sheer volume of ingredients.)
- With a large spoon, begin adding the dumpling batter into the pot, about 1/3 spoonful of batter, hold the spoon in the pot until the dumpling falls off. Repeat until all dumpling batter is finished. (Note: the larger the spoonful of batter, the larger the dumpling)
- Cover the pot and turn heat down to low, let simmer for about 15 minutes. The dumplings will rise a bit.
- Ladle into bowls and serve.


