### **Business meeting:**

### **RAC** grants

Tony said there was a meeting with our district ranger.

There are grant opportunities and RAC funding available. Also on our plate are the Gates of the Mountains trails covered under a separate grant.

Installing the site posts at Eagle Guard Station is also under a RAC grant and some trail clearing around Eagle Guard.

We would need to plan a weekend into Eagle Guard station to work on trail clearing. And then another trip would be necessary to install the site posts. Plus we were asked to do two pack trips for MCC crews working the Continental Divide trail.

The Forest Service expects to have five plus weeks of MCC time.

We expect there to be one pack into Black Mountain and one into Blackfoot Meadows (packing in crews).

This grant must be submitted by Feb 3 and so we must make a decision.

The RAC grant is two years: if we apply in February, we would have two years to complete (such as getting in the posts).

The last time we applied, we received \$27,000 and we got another \$5000 from another group so they could go in and spray weeds.

Neil suggests we should do it all. There is no reason we can't do the site posts. Blackfoot Meadows and Black Mountain (Nevada Mountain side) require a drop point from Marcus before we make a commitment. These will be the MCC crews comprised of 5 to 6 peeps and their gear and food.

Katy suggested we should schedule a few things for the entire group and then try to hit it piecemeal involving a few people at a time. That will be best for the project and for the club.

Tony will put something together based on comments from the group and see how it goes from there.

Jeff suggested that Katy should simply make a decision or we will lose a good trip waiting to hear from the group. She will follow up.
