

With the current restrictions the freeze branding as we know it will not be held this year, however, if you have an animal you would like to brand we can make arrangements to do the branding. Let Neil know 431-0130, / or mules2ride@msn.com

Plans for the upcoming trail work and packing are being designed to adhere with the guidelines set up by the Forest Service.

The requirement for the First Aid /CPR recertification training has been waived for a period of 12 months as of April 8, 2020. This only applies to the re-cert.

This interim directive (ID) extends sawyer certifications that have expired or will expire between October 1, 2019, and October 1, 2020, for not more than 1 year. This ID replaces direction currently contained in FSM 2350 section 2358.21, which provides that sawyer certifications expire 3 years after their effective date. This ID will become effective April 09, 2020 and will expire October 09, 2021.

Tentatively date June 6th for National Trails Day.

After numerous trips last year to clear the trails we couldn't get it done.

So this year the Forest Service is set to clear the trail prior to LCBCH packing and installing sight posts.

The packing is contingent on the trails being cleared.

Notification will be sent as project progresses.

Proposed hands-on chainsaw training and practice day for BCH sawyers.

Before we all head into the backcountry to clear trails, I thought it would be a good idea to spend a day checking out saws, safety gear, and sawing techniques. This is especially true because of the cancellation of the formal saw training from the USFS, and the desire of many members to take the training.

I am willing to spend a day (or more if there is an interest) in the field with BCH sawyers, going over simple and complex bucking methods required for us to safely clear trails. We would also cover saw sharpening, safe saw handling, and required safety gear.

All participants must wear the appropriate safety gear and have a saw or access to one. It would be a great time to make sure all club saws are ready to go for the field season.

A great location for the field day is the lower Minnehaha Creek area. There is good access, plenty of parking, and unlimited deadfall and blowdown. Hopefully a date would be sometime in May, after the snow is out of the area, and the Governor lifts the stay at home order.

For horses or mules


