- Note: BEAR funding for Woods Creek project not received yet; expecting it to direct deposit to bank account soon

OLD BUSINESS

• Katy D reported on state board meeting:

- New proposed logo/motto: 'Light on the Land', for BCHA spearheaded by BCHMT; lawyers reviewing for any copyright concerns
- Mountain/e-bikes still being discussed to address equine trail use concerns
- BCHMT is in need of an Education Chair
- 946 BCH members in Montana; numbers are again increasing (after COVID)
- Trout Creek Chapter is now defunct; most or all members went to High Plains Chapter
- BCHMT has \$58,000 available to chapters for mileage reimbursement only for USFS projects that are not reimbursed by other means; LCBCH chapter has limited mileage to be used for this as most of the club projects have other funding available
- BCHMT youth program; ages 14-17, level one (basics + camping) and level two (trip into wilderness + camping) first one did not fill up, second one did; they usually occur in August; if LCBCH chapter members know of youths who may be interested and/or qualify, they can get signed up when the opportunity is available in 2023; watch for updates on BCHMT
- Annual BCHMT chapter gathering: has been at Monture Creek campground/trailhead but the location may change in 2023
- Annual volunteer agreement; 2022 was initial year of agreement, it seemed to work well
- Holland Lake Lodge, development changes proposed; public comment welcome;
 BCHMT will compose a letter and comment regarding potential impact to trails in the area
- BCHMT continues to support Blackfoot/Clearwater Initiative
- BCHMT requested members to to help provide information/communication regarding local chapter area USFS and other US and state government activities so BCHMT can develop policy as needed; Krissy G volunteered to do this with Tony S as backup
- Inventory of LCBCH cargo unit storage and 'kitchen' trailer has been completed; both located at Neil and Darlene Horne's; the supplies belong to the club so use them if needed, be sure to check items out and in, if questions ask Neil H

NEW BUSINESS

- Tony reported the USFS will need more bridge planks hauled in the Woods Creek area in 2023; they may need about another 200 planks to complete repair/rebuild of the rest of the bridge crossings
- State Convention: LCBCH will be responsible in 2025; will need to start the initial planning in 2023; Kalispell is the location for the state convention in 2023 celebrating the 50th anniversary of Back Country Horsemen

- Promotional merchandise: brief discussion about LCBCH logo shirts, hats, etc. Precision Embroidery has the club logo; Terry H to find out prices of screen printing and embroidery and report at next meeting for further discussion
- Suggestions for speakers over winter: Katy D is contacting Chuck Whitmer, DVM; Cathy Lay (member and also MD) plans to discuss basic emergency medical procedures in March 2023
- No meeting in November
- Next meeting to be held December 7; discussions will include LCBCH chapter board elections and the New Year celebration in January; plan to attend the December meeting
