## Minutes – Last Chance Back Country Horsemen, Membership Meeting

- Guest Speaker: Dr. Cathy Lay, with PA Dawn

Topic: 1<sup>st</sup> Aid/Wilderness Tips - Dawn

- First = skin smaller wounds, clean with lots of water
- Second = stop bleeding, hold pressure about 10 15 minutes; use a gauze type pad on wound then wrap with coban/vet wrap or gauze wrap
  - If larger wound; clean as much as possible, again use pressure to stop bleeding, can use a tourniquet type device and place approx.. 6 inches above wound; depending upon wound, use pressure as needed; lots of pressure cuts off blood supply and the result is potential loss of limb, etc. (use your judgement); do not use super glue; if stiches are needed, it must be done within 24 hours
- Bones/orthopedic = use rigid support, this helps with the pain; splint with rigid device and place above and below break/fracture (to stop all movement), wrap splint in place, if it is an arm/shoulder injury, make a sling and keep arm close to body; Dawn did demonstrations of how to splint arm, knee and ankle
- Head injuries/falling = evaluate the person for possible concussion, example: slurred speech, blurred vision, confusion, etc., get help (if an older person, it is more important to get help soon as possible)
- Eye injury = wash if possible, if contacts do not remove them, cover both eyes (to stop movement) and get help
- Know your location to direct emergency personnel or do the best you can to get the injured person to a location to get help
- Take Roll
