- Some discussion about June 7th, National Trails Day work in the Gates, food receipts from York Bar; need to determine if or how the RAC grant will cover it; Jason H and Darlene H mentioned there will likely be reimbursement for food as Per Diem, as mentioned by Mandy Alvino at June meeting; in the meantime, keep your food receipts until this can all be confirmed

OLD BUSINESS

- Jason H signed a modification to the USFS RAC grant (current grant created by Allen Rowley)
- Jason also said there is another RAC grant application available; proposals due July 31st; Jason will talk with Sherri L and/or Allen R to determine if we should or can apply
- 2025 Work Projects:
 - Gates of the Mountains – Fred B mentioned there is still more to clear on trails within the Gates despite efforts to clear trails on June 7th; Mandy A had listed the Missouri River Canyon trail #257 as

a higher priority as well as Upper Mann Gulch trail #258, a medium priority; both trails on the west side of the Wilderness; John P suggested a group to clear or at least recon these trails July 21st; watch for more info to come

- Stove Camp/Woods Creek area - Katy D and John P co-trail boss; trail #118 needs to be cleared **before** August, 12th ; potential plan – set up camp at Stove Camp for membership get together and clear trail Aug 9 & 10; MCC crew plans to be there Aug 12 – Aug 20th to finish bridge building and/or fixing; LCBCH is also requested to haul in the tools and equipment for MCC Aug 12th and pack out August 20th; more info to come regarding this project once logistics are worked out with USFS & MCC
- June 7, National Trails Day; Gates of the Mountains Wilderness - Fred B is still missing driving mileage, stock use, time worked, etc. from some of the participants; be sure to submit info to Fred as there is potential for reimbursement from the RAC grant (either to you or the Chapter)

NEW BUSINESS

- Jason H mentioned the various emails to members from both BCHA and BCHMT to contact your political representatives/senators regarding federal budget items; namely changing public land to private and potential oil and gas drilling on public lands

OTHER BUSINESS

- John P asked about how best to get more members involved and participating in projects or just getting together in general; the chapter has long term members and newer members who are still learning; Neil H mentioned in his experience, good planning for bigger projects can get more members involved and getting to know each other and learn from experienced members
