## ATTENTION

Serious injury or even death can result from horse riding and related activities including any and all aspects of trail maintenance or reconstruction. There are risks inherent in equine activities, and these dangers or conditions that are an integral part of equine activities include, but are not limited to:

- The propensity of an equine to behave in ways that may result in injury or harm to, or death of person on or around the equine;
- The unpredictability of an equine's reaction to such things as medication; sound; sudden movements; and unfamiliar objects, persons or other animals;
- Hazards, such as surface and subsurface ground conditions;
- Collisions with other equines or objects;
- The potential of another participant to not maintain control over the equine or to not act within the person's ability

Participants in any SPWBCH activity shall act in a safe and responsible manner at all time to avoid injury to themselves and others, and shall be aware of the risks inherent in equine activities. The SPWBCH and its board of directors shall not be liable for injury to or death of a participant (and/or their equine) or damage to any personal property as a result of their voluntary participation in any chapter sponsored activity
