


This document summarizes FY21 USFS Trail

Vision for National Forest System Trails

National Forest System trails (NFSTs) are well-designed, well-maintained, and support recreation use today and tomorrow. Agency staff, partners, and volunteers work collaboratively across boundaries, are highly skilled, and have the resources they need to steward all National Forest System trails, as well as the ability to address emerging issues. All members of the public feel welcome and safe on National Forest System trails.

Mission of the WO Trail Program: Caring for land and serving people by professionalizing the trail program and improving processes to better support the collective trail workforce of agency staff, partners, and volunteers in order to provide a sustainable trail system that maximizes public benefits.







36,792 trail miles (or 23%) meet standard

National Forest System Trails Stewardship Act (P.L. 114-245) Highlights



Outfitter and Guide Trail Stewardship Credit Pilot Program: 696 miles of trail maintained in FY21.



Trail Maintenance Priority
Areas: 9,400 miles of trail
maintained and 226 miles of
trail improved in FY21.
Trail miles maintained down 2%
and trail miles improved up 30%
from FY20.



Fire study and National Volunteer and Partnership Strategy: A working group is carrying out a congressionally mandated study to identify coordination opportunities between fire and trail programs.



Volunteer/Partner total trail maintenance support: 1,308,443 hours; 26,692 miles (or 48% of all trail maintenance completed).

Trail Challenge Accomplishment Highlights


- **Online dashboard** to summarize national, regional, and forest accomplishments.
- Implementation technical guidebook for field staff.
- National and regional level meetings with agency staff and partners to raise awareness.
- Chief's leadership corner message inviting agency staff and partners to participate.
- \$1.8M of carryover funding distributed to regions for 10 YTC implementation.
- Secured 3,500 hours of Enterprise time to develop supporting products in FY22.

Great American Outdoors Act (GAOA) Implementation Summary

The Forest Service secured 569 million in GAOA funding to address projects that include a trail or major or complex trail bridge component, with an estimated deferred maintenance (DM) reduction of 1 billion once these projects are completed.

FY21 Accomplishments

Integrated accomplishments of the National Trail Teams: National Trail Board (NTB), National Scenic and Historic Trails (NSHT) Administrator's group, and Trails Advisory Group (TAG), including the saw and travel management programs. Fiscal year accomplishments are organized by the seven 10-Year Trail Shared Stewardship Challenge elements that guide the work of the national trail program.

10-Year Trail Challenge Element	FY 21 Accomplishment
A. Training	 Initiated development of trail core competencies in partnership with American Trails, Professional Trailbuilders Association, and other partners and agencies. Initiated an effort to build support for training and certification of volunteer major trail bridge inspectors.
B. Workforce	 Worked with Human Resources to resolve temporary employee hiring issues. Funded a multi-year study of trail partnership success factors with Virginia Tech and National Park Service.
C. Trail Sustainability	 Developed minimum criteria for assessing trail sustainability. Secured 3,500 hours of Enterprise time for FY22 Trail Challenge implementation. Funded 48 partner-led trail projects through the Trails Stewardship Grant Program that leveraged 6:1 on initial \$550,000 USFS investment. Initiated a study about best practices for engaging fire crews in trail maintenance activities.
D. Data	 Submitted a successful proposal for modernization and full re-design of Infra Trails, Trail Bridges and Access and Travel Management Applications beginning FY22. Piloted the use of Survey 123 to collect trail condition survey (TRACS) data. Piloted an online data dashboard to track Trail Challenge accomplishments.
E. Agency Processes	 Developed GAOA tips and tools documents to assist field staff with project proposals. Developed a composite deferred maintenance task in Infra to facilitate data entry for GAOA project proposals. Developed 10-Year Trail Shared Stewardship Challenge technical guidebook. Conducted a survey of field level trails staff to understand perceptions and experiences; held listening sessions. Established a new national level, 5-year MOU with Back Country Horsemen of America Developed a TRACS quick reference guide.
F. Working with Communities	 Hired a Trail Program Resource Assistant to add to the WO Trail Team's capacity. Worked with American Trails to develop two professional video productions inviting young people to work on trails. Funded three national level agreements to promote diversity, equity, and inclusion in trail program delivery.
G. NSHTs	 Began identifying amendments to Forest Service Manaual 2350 to provide better direction for NSHT management. Developed and promoted the National Trails System 101 training for line officers and forest staff. Re-established the interagency National Recreation Trail round table with the BLM and NPS. Improved website information about national recreation trails. Participated in annual Hike the Hill events (virtually).

National Crosscut and Chainsaw Program Key Accomplishments

- Initiated amendment of National Saw Policy (FSM 2358) to add clarity, remove conflicts and better align with new training curricula.
- Established new Oversight Committee to better integrate all Deputy Areas affected by Saw Program.
- Developed new sawyer training curriculum to better train agency employees, partners and volunteers.
- Developed Sawyer Qualification Tracking Database.
- Extended timelines for expired sawyer certifications due to COVID disruptions.
- Established Memorandum of Agreement with NPS which provides for reciprocity of sawyer qualifications for groups working on Nationally recognized trails crossing Agency jurisdictional boundaries.
